Bidders shall acknowledge this Addendum in the Bid Proposal by inserting its number on Page BP-1.

Question 1: *Are substitutions allowed?*

Answer: *Yes but any substitution must be a true equal to the specified product. Pad and Pour products are not considered equal.*

Question 2: *Is 480V power available?*

Answer: *Yes, a 480V panel is located in the boys' locker room.*

Question 3: *Is new vinyl base included?*

Answer: *Yes, four (4) inch vinyl base is included. Color to be selected from stock colors by owner.*

Question 4: *Is propane powered equipment allowed?*

Answer: *Yes, if equipment is rated for interior use.*

Bid Basis of Award and Bid Page have been revised:

The Town intends to award this work to one Bidder. Bidders shall submit a Bid on a lump sum basis for all line items in the Base Bid. The basis of award will be based upon the sum of any combination of the Base Bid line items selected by the Owner. The Town reserves the right to make a partial award of any of the line items in the lump sum base bid as deemed in the Town's best interest.
