### ITEM 2: ASBESTOS REMOVAL AT 131 ADDISON ROAD

The proposed asbestos removal work for the building remains at 131 Addison Road is hereby removed from this bid, and all references to this work in the Contract Documents are hereby deleted. Bidders are directed to ignore Item No. 3 for "Asbestos Removal – 131 Addison Road" in the Bid Proposal.

### ITEM 3: SPECIAL CONDITIONS - SECTION 6.00 DISPOSAL AREA

Replace this section with the following:

The Tryon Street Bulky Waste Facility will be available to the Contractor, at no charge, for disposal of materials that are accepted at that facility. In general, no materials containing lead-based paint of any level shall be dumped at the Tryon Street facility. Based on the TCLP test results for the waste stream expected from this project, demolition debris consisting of building construction materials only may be disposed of at the Town's Bulky Waste Facility. Recyclables, upholstered furniture, carpeting, and appliances are not accepted at the Bulky Waste Facility but may be disposed of at the Town's Transfer Station on New London Turnpike at no charge.

The Contractor is required to obtain a disposal area for all other waste or surplus materials that will not be accepted at either of the Town's refuse disposal facilities including materials that are hazardous or otherwise unsuitable at no additional cost to the Town.

# ITEM 4: TIME FOR COMPLETION:

Replace the following paragraph:

9.02 Asbestos abatement work shall commence within fourteen (14) days of the date of the Notice to Proceed / Purchase Order. After the asbestos abatement work has begun, it shall continue in an orderly fashion and shall be fully completed within fourteen (14) consecutive calendar days from the date of commencement.
