- A. Sewer Use Subcommittee

1. Subcommittee Recommendation Sewer Use Appeal for 117 New London Turnpike Account #802410

The Chairman commented that the Subcommittee on February 6 and recommended no adjustment and that parties are present to appeal this decision.

Gus Constantine, owner of 117 New London Turnpike, spoke and asked for consideration. After years of estimated bills, the MDC is billing them extravagant amounts. After much discussion between the owners, the members and Mike Bisi, including discussion on the water used by the Town for the rotary, it was decided that the Subcommittee would review the information again.

Mr. Davis MOVED that the Town of Glastonbury Water Pollution Control Authority RETURN this item to the Sewer Use Subcommittee.

Mr. Urbansky SECONDED the MOTION and it was UNANIMOUSLY APPROVED.

- C. Engineering Subcommittee
 - 1. Cider Mill Pump Station Replacement

Mike Bisi introduced Dennis Dievert and Nicole Ouimet of Wright-Pierce. Mr. Bisi noted that the Cider Mill Pump Station has been in operation since 1972 with all the equipment outdoors, and it has been working very well. It is now aging with frequent breakdowns and difficulty finding parts. They would like to enclose the equipment in an aesthetically pleasing building that would blend into the neighborhood. Mr. Bisi added that he had notified 11 abutters of the work to be done and invited them to tonight's meeting to look over the proposed design, and of those, Mr. and Mrs. Pettingell of 255 Cider Mill Road were in attendance.

Mr. Dievert displayed a not-very-good Google map looking down at the site. He also showed the members and the audience a drawing of the proposed building, with chimney for exhaust fumes; it will be 15 feet by 17 feet. Mr. Pettingell asked about noise; Mr. Dievert said if anything, it should be quieter with the station within a building. Mrs. Pettingell also asked about propane tanks. Mr. Dievert said they will be switching to diesel. Mr. Bisi elaborated, saying diesel will be easier to deliver in the event of bad weather. Mrs. Pettingell commented that she thought the building was attractive. Mr. Dievert (?) reiterated that neighbors will be included in meetings as the project goes through the Town's approval process.

Mrs. Pettingell asked how long the construction process will take, to which Mr. Dievert guessed about six months. A discussion then ensued regarding the cul-de-sac and right-of way.
