#### PRECIOUS METALS PERMIT

## **Application Procedure**

- 1) APPLICATION FOR LICENSE MUST BE NOTARIZED PRIOR TO SUBMISSION
- 2) \$10.00 FEE TO BE PAID AT TIME OF APPLICATION
- 3) FBI AND STATE FINGERPRINT CARDS TO BE MADE OUT AND MAILED FOR CLEARANCE.

There is a \$13.75 processing fee charged by the FBI for this service and a \$75.00 fee charged by the State. These checks need to be made payable to "Treasurer, State of CT" and must be submitted at the time you are fingerprinted for this permit.

PURSUANT TO SECTION 21-100 OF THE CONNECTICUT GENERAL STATUTES, THE CHIEF OF POLICE, IN HIS SOLE DISCRETION, MAY ISSUE A LICENSE. NO LICENSE SHALL BE ISSUED TO ANY PERSON WHO HAS BEEN CONVICTED OF A FELONY.

(CGS) section 21-100(b) requires you to keep a written record documenting all transactions. This record shall include a full, detailed description of each item purchased, the price paid for each item, the date and time that the property was purchased and positive identification, including the address of person(s) selling the property with the form/type of identification noted in the record. Positive identification from person(s) selling goods must include a photograph, In addition, Sec. 21-100(c) states a licensed person may only pay for goods received by check, draft or money order and no cash shall be transferred to either party in the course of a transaction, which includes the cashing of the issued check, draft or money order.

The Glastonbury Police Department accepts electronic receipt of the records you are required to produce and submit. The Police Department will provide you with the proper spreadsheet format in template form for this purpose. You are also required to:

- hold the items that you purchase intact for a minimum of five (5) days.
- assign a transaction number to each item purchased.
- take and keep a digital photo of the item(s) purchased for a minimum of one (1) year, referencing each photo to the assigned transaction number.
- make and keep a photocopy of all photo identification presented by the seller for a minimum of one (1) year.

The license may be revocable for cause, which shall include, but not be limited to, failure to comply with any requirements for licensure specified by the licensing authority at the time of issuance.

All principals in the business must be named and the applicant shall specify all storage areas for the business, which shall be open for random inspections by any State or municipal police officer or designee of the Glastonbury Police Chief.
