Town Manager's Report

Dear Council Members:

The following will keep you up to date on various topics.

1. GFOA Certificate of Achievement for Excellence in Financial Reporting - FY End 2017

I am pleased to advise the Comprehensive Annual Financial Report (CAFR) for the fiscal year ended 2017 qualifies for the GFOA Certificate of Achievement for Excellence in Financial Reporting. The Certificate of Achievement is the highest form of recognition in governmental accounting and financial reporting. This is considered a significant accomplishment by a government and its management. Congratulations go to Director of Finance Julie Twilley, Controller Nina Cousins, and all those contributing to this ongoing national recognition.

2. Food Waste Collection Program

Over coming weeks, a food waste collection process will be available at the transfer station. This will supplement ongoing organics recycling involving composting of leaves and grass. The Town will work with All Waste to have a collection container available with material transported to the recycling facility in Southington. The process is estimated to be generally cost neutral and continue Town efforts to encourage recycling. Superintendent of Sanitation Mike Bisi is coordinating this initiative.

3. Riverfront Boathouse

Coaches from the University of Connecticut, including Geno Auriemma, Jim Penders, Dan Hurley, and Randy Edsall, are holding four gatherings throughout the state sponsored by the UConn Foundation. The purpose of the events is for attendees to talk to the coaches and hear about plans for the various programs. I am pleased to advise that the Riverfront Boathouse was selected as the area location for one of these gatherings. The event held on Monday, June 4th attracted over 250 attendees.

4. Route 17 Widening

The attached letter is received in response to the Council's request that State DOT consider options for widening the shoulder area along Route 17 between Main Street and Hopewell Road.

5. Staff Work

Attached are examples of correspondence recently received concerning good work by members of Town staff.

6. National Recognition - ICMA

I am pleased to advise the Glastonbury Riverfront Park has been selected to receive national recognition through the International City and County Managers Association. Glastonbury is among 14 communities nationwide to be recognized with a Program Excellence Award. The application prepared by my office cites the 20+ year evolution of the Riverfront Park including land acquisitions, road relocation, environmental remediation, construction of the Community Center, Riverfront Park Phases I and II, community partnerships, grants, referendum approval, and other such factors. The award will be formally presented at the ICMA Annual Conference this September to recognize the work of local government managers.

7. Public Water Service

Over recent years, the potential to work with the MDC to develop a plan to extend public water service in Glastonbury has been discussed. This would involve service to existing properties with costs borne by property owners through a benefit assessment like the sanitary sewer process. Areas considered would include neighborhoods on private wells experiencing issues with radon, uranium, supply, quality, and other such matters. I was asked to reference this topic as part of my written report so that as applicable, discussions could be initiated with the district.

8. Hubbard Green

The Green Park Association is proceeding with re-landscaping of the monument area at Hubbard Green. This includes significant removal of existing landscaping. New work includes re-landscaping, pavers, handicapped accessibility, etc.

9. Intersection Reconfiguration

The Town Center traffic study completed in cooperation with Fuss & O'Neill in 2008 identified alignment of Douglas Road/Sycamore Street as a potential project. This is shown on the attached page. The residential property at the corner of Douglas Road and New London Turnpike (NLT) was purchased by the Town for this potential. As State DOT continues to plan for realignment of Route 17 exit and entrance ramps to NLT, a suggestion is to coordinate the Douglas Road/Sycamore Street intersection with the DOT project. This will require design of the reconfigured intersection and possible improvements to Douglas Road including sidewalks, traffic calming, etc. I was asked to reference this topic as part of my written report. Representatives from State DOT are scheduled to attend the June 26th meeting to discuss the Route 17 exit/entrance ramp project.

10. National Recognition - NRPA

The National Recreation and Park Association has recognized Phase II of the Riverfront Park Project with its Innovation in Park Design Award. Phase II includes the Boathouse, terrace, overlook, basketball court, parking and access, children's playground, skating area, and related improvements. The Park will also be considered for the Best in Innovation Award.

11. Communication Tower - Woodland Street

The attached correspondence by Attorney Laub with attachments is forwarded concerning the Town's request for a monopine structure at the Woodland Street site. Please let me know your preference in this regard.

Subject: Route 17

Thank you for your April 26, 2018 letter to the Department of Transportation (Department) regarding your concerns about Route 17 and the limited shoulder width between Main Street and Hopewell Road. In your letter you requested a preliminary review so that potential options for widening the shoulder can be understood. The Department's preliminary in-house review identified one potential short-term option: widening the shoulder width within the existing roadway during resurfacing (via lane width reduction).

The Department's in-house preliminary review identified some initial information on this 1.25 mile section of roadway. Beginning at the end of the Route 17 expressway (Glastonbury Expressway), the roadway continues south as Main Street and is a two lane arterial through a mixed residential and light commercial area. The average daily traffic (2012) at the expressway's end is approximately 17,700 vehicles and steadily decreases to approximately 14,100 at Hopewell Road. The roadway cross section is not consistent through the 1.25 mile section. Lane widths vary from 12 ft. to 14 ft. throughout, with similarly inconsistent shoulder widths (approximately 1 ft. to 4 ft.). The most recent available three-year crash history showed the heaviest concentration of crashes to be at the intersection of the Glastonbury Expressway, Main Street, and Buttonball Lane. Rear-end type crashes were the most prevalent crash type through the corridor, mainly located at side streets and driveway locations. There were no serious injury or fatal crashes, and no bicycle or pedestrian crashes were Identified.

In recent years, the Department has championed several initiatives that support non-motorized users such as bicyclists and pedestrians. In 2014, the Department implemented a Complete Streets Policy in accordance with Section 13a-153f(a)(d) of the Connecticut General Statutes, Accommodations and Provisions of Facilities for All Users. Connecticut's Complete Streets law (Conn. Gen. Stat. §13-153f) requires pedestrians, cyclists, and transit users to be routinely considered in the planning, designing, construction, and operation of all roads.

As you may be aware, this section of Route 17 is scheduled to be resurfaced during the Department's 2018 Vendor-In-Place (VIP) Resurfacing Program. Roadway milling will tentatively begin the week of June 11, 2018, with the resurfacing beginning the week of July 9, 2018. As part of this resurfacing program, the Department attempts to minimize the vehicular lane widths, where possible, to 11 ft., in order to provide a wider shoulder area for pedestrians and bicyclists. These improvements will be implemented to the maximum extent feasible where the existing roadway width and number of travel lanes allows. It should be noted, however, that this type of project is completed within the existing roadway width; therefore, it does not incorporate the construction of sidewalk or roadway widening for increased pavement width.

Beyond the lane width reductions that will be incorporated into the resurfacing project, there are no current roadway projects under consideration by the Department in this area. We suggest that you work with the Capitol Region Council of Governments (CRCOG) to consider a comprehensive study to determine the best strategy to address all of the transportation needs and deficiencies along the corridor, while being mindful of the existing land use and character of the area. For example, widening at key locations may reduce the number of rear-end crashes and serve as a better strategy than broad scale widening.

Finally, on a related issue, on July 31, 2017, through the Department, the Town applied for a Community Connectivity Grant. The request was for the installation of approximately 1,250 linear feet of concrete sidewalk on the west side of Main Street (Route 17) between the Stockade Road intersection and the intersection with Red Hill Drive. This grant program is subject to approval by the Bond Commission. Unfortunately, due to the state budget shortfall, this grant program was one of the programs put on hold. The state legislative session just ended on May 9, 2018, which included an adjusted state budget for FY 2019, and the Department is now evaluating how and when to proceed with the many programs that had been put on hold. We will provide you with an update on the status of this grant application after the program receives Bond Commission approval. While we do not know either the timing or the amount of any future Bond Commission approval for this program, the Town had a strong application and we are hopeful that funding will be made available.



Approved Wireless Telecommunications Tower Facility

Re:

I am writing to you on behalf of Eco-Site, Inc. ("Eco-Site") in furtherance of the recent Siting Council approval of the captioned facility. The Connecticut Siting Council approved the proposed facility by Decision and Order dated March 29, 2018. A copy of the Opinion and Decision and Order are included as **Attachment 1.** This letter is in furtherance of that decision which included as a condition of approval consultation with the Town of Glastonbury regarding the Town's emergency communication equipment needs and the appropriateness of a monopole or stealth tree ("monopine") design based on those needs whereby the final design shall be determined after this consultation.

Monopole and Monopine Photo Simulations

As per your request I am enclosing photo simulations of the approved facility in both monopole and monopine formats as **Attachment 2** to this letter. The tower was approved at a height of 150' above grade level ("AGL"). These simulations were originally generated pursuant to the Town's request to the Siting Council for the applicants to analyze "stealthing" and were reviewed and discussed at the Siting Council's continued hearing on February 8th.²

Surrounding Context

The objective of a monopine design is to mitigate visual impacts by blending the appearance of the facility with existing topography and trees to effectively hide it from plain view. The success of visual mitigation of this type is determined by the surrounding landscape and viewpoint context. In this instance viewpoints offering the most complete views of the tower offer little surrounding context for the monopine approach.

Height Context

A "tree" the height of 155' AGL would far exceed the surrounding tree canopy that ranges between 50' to 70' AGL. Notably, the area of the approved tower includes a mix of largely broadleaf trees with some evergreen trees along with underbrush and young growth prominent along the existing access drive. This is consistent with the site's location in the Eastern Broadleaf Forest (Oceanic) Province which is generally characterized by a winter deciduous forest dominated by tall broadleaf trees that provide dense, continuous canopy in the summer and shed their leaves completely in winter. Field review confirmed that the forest overstory around the approved facility is dominated by oaks (white, black, red), American beech, black birch, hickories (shagbark, pignut), eastern hemlock, witch-hazel, and maple-leaved viburnum.

Given the lack of similar context, certain views of the facility, particularly from Matson Hill Road area, would present a wide silhouette and an unusual height as a monopine. The industry's general experience is that this wider profile and out of place appearance draws the eye and is more noticed than a monopole. Other views may provide some background context in which the monopine may blend however those views are also of a smaller portion of the tower at distances such that the relative amount of mitigation gained is, on balance, minimal. Importantly, as discussed below, emergency equipment cannot be successfully concealed within the monopine branches.

Town of Glastonbury Emergency Communication Equipment

Equipment Needs

As per your email to me on April 26, 2018 we understand the town has the following technical needs:

- 1. 800 Antenna DBSpectra DS7A06F36U6D (20' whip antenna) fed with 1 5/8" heliax;
- UHF Antenna DBSpectra DS4Co6F36U3D (20' whip antenna) fed with 1 ¼" heliax; and
- 3. Microwave (3' dish) fed with 1/2" heliax.

We obtained specification sheets of these antennas which are included as **Attachment 3**. In addition, we understand that the Town ideally desires this equipment to be located at the top of the tower with a triangular support structure with the microwave dish at 145' on the tower. At grade the Town would need to install an outdoor cabinet (DDB 2OD-78DDXC) placed in a location that allows for future expansion. This cabinet will be serviced by two Pentair ACP-

8000-N36-220 air conditioners and 100A electric service is required to power the Town's equipment.

Location of Emergency Equipment

We understand that the Town prefers its equipment at the top of the tower. Please note that it is important to Eco-Site and T-Mobile, and likely the Town, that adequate distance be maintained between all antennas on the tower. Moreover, the T-Mobile lease area goes up to the very top of the tower. The triangular support could be located on a small extension or attachment to the tower extending above 150' AGL. The 20' whip antennas and 3' dish would then be installed on that extension. Assuming a 5' – 10' extension to the approved 150' AGL tower the whip antennas would reach a height over 170' AGL.

Stealthing, Emergency Equipment and Operational Costs

In general, when there is a lot of equipment on a monopine tower, the effect of the stealthing is compromised by infrastructure that cannot be concealed within the "branching". Here, the antennas will rise 15' to 20' above where the monopine branching would end. As such, the majority of the whip antennas will not be concealed and would rise well above the top of the monopine structure. Though slim, the antennas will be visible to nearby views confirming its function as a communications tower and undermine the effect of the branching. The dish antenna may be somewhat concealed but still discernable.

It should also be noted that additional costs will also be incurred by carriers and the Town as the branching on the monopine makes for more involved equipment deployment and maintenance processes. Installation, maintenance and repair on a monopine requires more time and use of a crane to account for the branching. This translates to additional costs for all users of the tower including the Town.

Conclusion

As a follow-up to this letter I will call your office to discuss the process for moving this discussion forward. Thank you for your time and consideration in this matter.










Simulated Condition - Monopole with Emergency Communications Antennas VP21 - Matson Hill Road (near #519)









