# 2. Action on appropriation and transfer Capital Reserve Unassigned Fund Balance \$250,000 to Cedar Ridge Water Service

Mr. Johnson reviewed his memo to the Board and explained the unhealthy levels of uranium in the water for some of the homes. He noted that the Town of Manchester requires the agreement with the Town of Glastonbury. He continued saying it would be funded by the residents and the income would be handled like the receipt of a grant. He said that they have a preliminary estimate of \$215,000, are collecting \$250,000 to allow for contingency and will rebate any of the project money unspent back to the residents undertaking the project. Chairman Constantine asked about the other neighbors. Mr. Johnson encouraged those involved to seek legal counsel about how to be handle and be protected through this process.
