LIAISON REPORTS:

<u>AARP</u>: Gerrie Bishop reported that the chapter was working on two upcoming fundraisers including a trip to a casino and a proceeds sharing fundraiser at the 99 House.

HUMAN SERVICES REPORT:

Patti White updated the group on the activities of the Senior Services department, highlighting the large response to the upcoming grant funded Tai Ji Quan Moving for Better Balance series scheduled to start in April. Patti also reported that approximately 190 seniors attended the St. Pat's Day luncheon and that the 3rd series of the Aging Mastery program was going well.

Lisa Zerio informed the members that based on program and funding considerations, the Senior Services and Social Services departments would now be part of the town Parks & Recreation Department.

OLD BUSINESS:

Rosemary and Patti updated the group on the latest developments with the Age-Friendly Livable Communities initiative. Rosemary stated that an article explaining the initiative would be in the Glastonbury Life in April and in the Citizen the week of March 18th. Patti reported on the meeting she attended in Greenwich with the AARP Age-Friendly representative and the other 3 towns in Connecticut undertaking the effort. She stated that each of the communities is in a different stage of development and that AARP may be able to do the analysis of Glastonbury's on-line survey responses.

Darren Hill updated the members on the status of the stakeholder's list and asked the members to review and add any additional contact information that they may have.

The group discussed the questions raised by the Glastonbury Education Foundation in response to the Letter of Intent submitted in March. Patti will incorporate their feedback into the full application which is due on April 1.

The group decided to attend the April 9th Town Council meeting to invite the council members to the May 16th Community Forum and to ask them for a champion of the Age-Friendly initiative.
