Summary background information is as follows:


- Two well attended community workshops were held to seek input and discuss project scope options.
- Three general options are identified. These can be refined as applicable.
- Scope options are intended to provide opportunities for a wide range of ages and interests.
- Capital costs and operating expenses/revenues are preliminary order of magnitude.
- Estimated capital costs include an allowance for site improvements but not site acquisition.
- A 4± acre site (subject to configuration) is identified for the options to be presented.
- Approximately 255± parking spaces would be required per Building Zone Regulations.
- Subject to project scope, a new facility could accommodate other uses (e.g. gymnastics) and return the Academy gymnasium to a variety of programming uses.
- The schedule for a November referendum requires legislative actions June through August.

Based on Tuesday evening's presentation and discussion, additional information can be provided as applicable.

Re: Condition of Approval – Turning Lane – The Tannery

Dear Council Members:

When Flanagan's Landing (now The Tannery) was approved per the Adaptive Redevelopment Zone Regulation (ARZ) in August 2013, a Condition of Approval required review of left-hand turning movements to the entrance drive. This is the left-hand turn to the entrance drive to the apartment complex when heading southeast on New London Turnpike. The developer was required to post a performance bond subject to final review by the Legal Traffic Authority (Chief of Police) to ensure funding for additional widening of New London Turnpike or a dedicated left-hand turn lane. This Condition of Approval extended one year following issuance of the final Certificate of Occupancy. The one year ends this June.

As noted in the attached memorandum by Chief Porter, this matter has been monitored over the months and no issues with left-hand turns to the entrance drive are noted. Accordingly, no further expansion or turning lane construction is suggested.

Council action is not required, however, I did want to provide this update and have asked Chief Porter to attend Tuesday evening's meeting to review and respond to any questions.

a. Action to Transfer Uncollected Taxes to Suspense List

The Board of Finance, at its Wednesday, May 15, 2019 meeting, unanimously recommended a \$137,111.78 transfer of uncollected taxes to the Suspense List. This action will clear the books for financial reporting purposes but not relieve the tax liability or lessen collection efforts. The Collector of Revenue will continue efforts to collect these taxes. Suspense taxes collected are credited to the prior year tax account. Approximately \$91,775.06 in prior Suspense List taxes have been collected over the past year.

"BE IT RESOLVED, that the Glastonbury Town Council hereby approves the transfer of \$137,111.78 of uncollected taxes to the Suspense List as described in a report by the Town Manager dated May 24, 2019 and recommended by the Board of Finance."

2019 Neighborhood Assistance Act Program (NAAP)

This state program allows businesses to contribute monies to programs sponsored by municipalities and non-profit organizations. The contributions are eligible for state corporate tax credits (60%-100%) and federal tax credits of 100% of the value of the charitable donation. Local legislative approval is required by the NAAP. Proposals are reviewed by state offices and approved under program criteria. Program sponsors then seek business funding support. Maffe Foundation and Connecticut River Valley Chamber of Commerce have submitted the attached proposals for the 2019 program. A Council public hearing and action is required.

Re: Town Manager's Report

Dear Council Members:

The following will keep you up to date on various topics.

1. Small Cell Wireless Antenna

A question was recently asked on the installation of small cell wireless antenna equipment on utility poles located in the public right-of-way. These installations are coordinated by Cellco Partnership (Verizon Wireless). This was the topic of discussion at the October 23, 2015 Council meeting when Attorney Richard Smith of Robinson & Cole attended to describe the proposed installations and process. Attorney Smith represents Cellco in this matter. In 2015, 11± locations were cited along Hubbard Street, Main Street, Oak Street and Griswold Street. The placing of the small cell equipment on utility poles is regulated by the Public Utility Regulatory Authority (PURA). The process requires notice and consent by adjoining property owners. If such consent is not granted, the equipment cannot be installed without approval by PURA. A public hearing at PURA can also be requested by property owners.

In July of 2017, Council was advised of two additional locations along Manchester Road. With proposals to date, the Town has not opted to take intervenor status or to hold public information hearings. As I understand, aesthetics is not a factor considered by PURA. Additionally, if the equipment satisfies FCC standards, PURA cannot enact additional requirements. For equipment attached to existing utility poles within historic districts, there can be no further requirements promulgated by PURA.

At this point, I am not aware of additional proposed installations. This is not a Town project and again, the matter is regulated by PURA. When communication towers have been proposed in the past, small cell installations are often suggested as an option. Additional information can be provided as may be requested.

2. Western and Eastern Boulevard Parcels

As requested, signs are now located at the two parcels owned by the Town located off Western and Eastern Boulevard to help actively market these properties.

3. Communication Tower - Woodland Street

The Siting Council approved a monopole for the communication tower to be located at 63 Woodland Street – Cavanna property. The Town Council had requested a monopine. Action by the Siting Council recognizes the Town will be allowed to install public safety communications equipment at this location.

4. Private Wells - Uranium

The attached page updates the map forwarded at the May 14, 2019 meeting. This includes results of 30 parts or less.


5. Petition - Clinton/Linden Street

The attached petition is received from property owners along Clinton and Linden Streets. Town staff and I have reviewed these topics and responded to all questions. This was much appreciated by the contact for the petition. The streets will be paved this summer. Speed monitor units will be placed to alert drivers of their speed and the Police Traffic Unit will also monitor rates of speed. I was asked to forward the petition for Council information.

The names listed on the attachment represent owner of homes on Clinton Street and Linden Street.

For generations these two streets were considered "The Cut through Streets" in order to bypass the congested intersection of Hebron Avenue and New London Tpke.

When the two "Round Abouts" were being constructed the traffic using "The Cut through Streets" went above and beyond. It was not just passenger cars but also many, many large trucks carrying heavy loads of gravel and other products used in the construction of the "Round Abouts".

We realize there is going to be more construction to begin at the corner of Hebron Avenue and Linden Street. This is definitely of great concern to the homeowners on Clinton Street and Linden Street. It is imperative the Town of Glastonbury take into

consideration all that the residence have been going through for the past few years and draw up some guidelines for the company that is constructing the new building. It is definitely going to cause more upheaval for the residents and we are well aware that the construction company will plan on using Clinton Street and Linden Street to bring in all that is needed for the project.

When the roads have been repaved and the construction completed at the corner of Hebron Avenue and Linden Street would it be an option for the Town of Glastonbury to put in effect a limit on the size of trucks allowed on these streets?

The homeowners of Clinton Street and Linden Street would appreciate The Town of Glastonbury to consider the proposal presented to them.

The Glastonbury Town Council with Town Manager, Richard J. Johnson, in attendance, held a Regular Meeting at 7:00 p.m. at the Council Chambers of Town Hall, 2155 Main Street, Glastonbury, Connecticut.

2. Public Comment.

Ms. Laura Levine of 12 Tanglewood Road expressed support of the plastic ban ordinance. She spoke to the 10 to 1000 years it takes for a plastic bag to decompose and the benefits gained by cities and towns who have already taken action She said that based on her experience in Stop and Shop, she does not believe many will change their ways on their own.

Ms. Patricia Taylor, Director of Environmental Human Health, Inc., expressed support of the plastic ban ordinance. She spoke to the health issues from plastic micro particles and of the towns and cities that have already taken action.

Ms. Denise Weeks of 233 Hollister Way West, expressed support of the plastic ban ordinance. She said she was the liaison for livable communities and invited all about the upcoming event at the Riverfront Community Center.

Ms. Candice Maningas of 202 Indian Hill Trail, expressed support of the plastic ban ordinance saying that there is no question about the health issues related to plastics and all levels of government need to take action. She urged the Council to send it to public hearing and encouraged the fee on paper bags.

Ms. Tricia Matson of 61 Colton Road, expressed support of the plastic bag ordinance.

Janet Bryant of 248 Hollister Way West, expressed support of the plastic bag ordinance.

Ms. Audrey Beatty of 2025 New London Turnpike, expressed support of the plastic bag ordinance and felt that this was the least the town could do.

Mr. Luther Weeks of 233 Hollister Way West, expressed support of the plastic bag ordinance saying some grocery stores are doing it on their own. He said they should take action for the whole region to keep plastic out of their water.

Ms. Lexie Thompson of 252 Bluff Point Road, said that she is a high school student and they need to take action now for her future.

Ms. Laura Smith of 1459 Neipsic Road, said that she took environmental science this year and banning plastic bags is one small step to help the environment and reduce health risks.

Mr. Johnson said that the town was recognized as a bike friendly community and every four years, they must reapply. He said they were recently reaffirmed. Vice Chairman Niland read the resolution noting May as Bicycle month and the many benefits of cycling.

Ms. Carroll said that they would like to send it to public hearing and solidify the timing of the proposed rollout after. She reviewed the options for the ordinance. Mr. Norman said he thought they were going to decide which option at this meeting before the public hearing. He said that

this would exclude the "pick-your-own" bags and called the effort collaborative. He asked about the state status. Mr. Johnson said that there are proposals and they are monitoring it.

BE IT RESOLVED, that the Glastonbury Town Council await the end of the legislative session to hold their public hearing in case there is progress on this issue at the state level, thus, June 11, 2019.

Vice Chairman Niland said that they could hold the public hearing but not take action until later, if desired, but he favored having the public hearing earlier. A RESOLUTION ADOPTING THE CAPITOL REGION NATURAL HAZARD MITIGATION PLAN UPDATE, 2019-2024

WHEREAS, the Town of Glastonbury has historically experienced severe damage from natural hazards and it continues to be vulnerable to the effects of those natural hazards profiled in the plan (e.g. flooding, high wind, thunderstorms, winter storms, earthquakes, droughts, dam failure, and wildfires), resulting in loss of property and life, economic hardship, and threats to public health and safety; and

WHEREAS, the Glastonbury Town Council approved the previous version of the Plan in 2014; and

WHEREAS, the Town of Glastonbury and Capitol Region Council of Governments developed and received conditional approval from the Federal Emergency Management Agency (FEMA) for the Natural Hazard Mitigation Plan Update, 2019-2024 under the requirements of 44 CFR 201.6; and

WHEREAS, public and committee meetings were held and public input was sought in 2017 and 2018 regarding the development and review of the Natural Hazard Mitigation Plan Update, 2019-2024; and

WHEREAS, the Plan specifically addresses hazard mitigation strategies and Plan maintenance procedure for the Town of Glastonbury; and

WHEREAS, the Plan recommends several hazard mitigation actions/projects that will provide mitigation for specific natural hazards that impact the Town of Glastonbury, with the effect of protecting people and property from loss associated with those hazards; and

WHEREAS, adoption of this Plan will make the Town of Glastonbury eligible for funding to alleviate the impacts of future hazards; now therefore be it

RESOLVED by the Town Council:

- 1. The Plan is hereby adopted as an official plan of the Town of Glastonbury;
- 2. The respective officials identified in the mitigation strategy of the Plan are hereby directed to pursue implementation of the recommended actions assigned to them;
- 3. Future revisions and Plan maintenance required by 44 CFR 201.6 and FEMA are hereby adopted as a part of this resolution for a period of five (5) years from the date of this resolution.
- 4. An annual report on the progress of the implementation elements of the Plan shall be presented to the Town Council.
