**2019 Recommended Sewer Use Rates**

- A. \$ 3.15 per ccf for 100 percent of metered flows.
- B. \$ 3.15 per ccf for non-metered flow of 140 ccf.
- C. \$ 0.075 per gallon of septic sewage.
- D. \$20.00 surcharge for reading private meters.
- E. \$60.00 minimum bill/standby charge.

Emergency Incident Report

120 Hebron Avenue**

Greg Mahoney said he received the attached Emergency Incident Report from the CT DEEP notifying the Town that a spill was reported. The report stated employees at one of the restaurant establishments were dumping grease into a catch basin. A citizen had called CT DEEP to report the violation. Upon receipt of the violation, Mr. Mahoney issued a letter from the Water Pollution Control Authority to the property manager, notifying them of their violation of the CT DEEP Fats, Oils, and Grease (F.O.G.) General Permit for restaurant establishments. Mr. Mahoney then had a phone conversation with the CT DEEP Inspector, in which the Inspector stated he had the property owner clean out the effected storm drainage system located on the property at Eric Town Square.
