INTRODUCTION

Most households have these products: gasoline, oil-based paints and stains, pesticides, insecticides and household cleaning products, to name a few. How we dispose of these materials can be problematic. Also known as household hazardous waste, if disposed of improperly, significant environmental impacts may result. With increased public awareness of the environment, many Towns were faced with developing programs for the safe disposal of these materials. Individual municipal programs proved very costly. Glastonbury's solution was to develop a cost-effective and convenient regional solution for its residents.

REGIONAL HOUSEHOLD HAZARDOUS WASTE DISPOSAL

In 1996, the Town of Glastonbury, along with the Towns of Hebron, Manchester, Marlborough, Somers, Stafford and Vernon, formed the Capital Region East Operating Committee (CREOC) and received State of Connecticut, Department of Environmental Protection (DEP) funds to construct a permanent hazardous waste collection facility in the Town of Manchester. The seven towns of CREOC serve a population in excess of 150,000 people.



While latex paints may be dried out and disposed of with regular refuse, oil– and lead-based paints are hazardous materials and must be

This facility provides an economical and environmentally sound disposal alternative for disposing of household hazardous materials, such as oil-based paints, thinners, solvents and cleaners.

A product is hazardous if it has at least one of the following properties:

- toxicity
- **9** flammability
- corrosiveness
- reactivity

Examples of household items which may contain elements requiring them to be disposed of as hazardous waste:

- Acids
- Cleaners
- Fluorescent light bulbs/lamps
- Mercury-containing products
- · Oil-based paints
- Paint thinners
- Pesticides and insecticides
- Solvents

Many times, these materials are disposed of by dumping down the drain or discarding in the trash. These improper disposal methods result in potentially significant environmental impacts to our water supplies and land, and harm to wildlife and humans.

Our regional approach has resulted in a very successful program for our community.
