Jeffrey	Wihbey	1125 Chestnut Hill Rd	Dear Town Council Members, I respectfully write to you as an almost twenty year Glastonbury resident advocating for a tripling of the annual Capital Improvement Program budget for funding of sidewalks. The current pace of sidewalk construction has not adequately kept up with community needs. The current budget allocation is woefully insufficient. I am specifically requesting a contiguous sidewalk between Hopewell School and Hopewell Street along Chestnut Hill Road. This stretch is a very busy road seeing car travel at high rates of speed. This is also a stretch that services school aged children and many walkers and joggers. There should be an eventual sidewalk along Chestnut Hill Road connecting Main Street and New London Turnpike based on the large number of residents who could potentially utilize it. I must add that the rate of sidewalk construction within the Hopewell School zone has noticeably lagged other areas of town. I am also very concerned about the stretch of road on New London Turnpike that has no sidewalk. I frequently see kids walking from the high school on that busy road with no sidewalks. There is a disconnected set of sidewalks on NLT that needs to be connected. That sidewalk should go from GHS all the way up to Country Club Road. GHS is a community center and should have sidewalks leading to it for several miles. This is dangerous and is concerning to me and many of my neighbors as well. We need to work on making Glastonbury a much more walkable community. Much more walkable and safer. This is my third such request of the town council over the years with no action.
