cameras, the Spec for the work only lists locations for 4 cameras in Town Council Chambers,

Are the remaining 3 cameras to be installed in Meeting Room A?

Answer: 4 cameras mounted in Council Chambers, 3 cameras will be used in a mobile setup that will not

be mounted.

Ouestion 3: Attachment B Equipment List Items 27-30 and 54: Items 27-30 are for a Custom TBC

Council for SmartTrac Edit Desk and MiddleAtlantic ELUR-DC 84 Inch Desk with 2 Rackbay Overbridge - Dark Cherry. Both items would be the item installed in III, D, 1: The new console furniture item, is there a need for one or two consoles to be installed in this location. Drawing No. AV-501 calls for the Middle Atlantic Desk, please specify which

console you would like to proceed with.

Answer: Line Items 27-30 and delete Item 54 and it's installation.

Question 4: The JVC-SR-HD2700US-BLU-RAY DISC & HDD RECORDER w/HDSDI has been

discontinued by the manufacturer, reaching out to find a replacement and at the moment it

does not appear to exist.

Answer: Replacement recorder, Niagara Video Corporation HDI-SDI Recorder.

Question 5: The equipment list calls for one of the following: Item 60: Shure SCM810, 8 Channel Mixer.

In Adenda 2 Question 5: Please provide a list of equipment that the Town currently has that will remain. Answer: The following equipment will remain: 2 SCM810 Shure Mixers for

Council Chambers. Please clarify if a third SCM810 Mixer is needed.
