AGE: 65 (BY 12/31/2020) AND OLDER OR RECEIVING SOCIAL SECURITY DISABILITY
INCOME LIMIT: SINGLE PERSON \$37,600 / MARRIED COUPLE \$45,800
Resident of Connecticut at least 1 year prior to application
There is no asset limit for this program
