#### **QUESTION AND ANSWERS**

- 1. Question: Provide clarification on riser diagram for bid #2 and #3. Answer: Clarification provide in attached sketch SK-E102.2.
- 2. Question: Provide clarification on fuel tank size for generators.

  Answer: The sub base tank for the 50 kw generator shall be sized to provide a minimum of twenty four hours of run time at full load. The sub base tank for the 200 and 350 kw generators shall be a minimum of 300 gallons.

- 3. Question: Provide clarification on fuel supply pumps for generators.

  Answer: A return fuel pump for overflow (partial day tank kit) is required for the 200 and 350 kw generators. The fuel supplied to the sub base tank will be as shown in detail E2 on drawing E-102.
- 4. Question: Can a school calendar be provided?

  Answer: Calendar is attached to this addendum. Note that dates are subject to change based on educational program changes, weather, etc.

- 7. It was determined that the feeders to the gym loads exit the electrical room underground in the pull section of the switchgear. Attached sketches SK-E102.1, SK-E102.2, SK-E103.1 & SK-E103.2 show the changes in scope or work required for interrupting this feeder and feeding it through the manual transfer switch.
