Meter shall be mounted on wall adjacent to panel. Provide 20 amp, three pole, circuit breaker for meter in panel 1EMP2. This work is part of Base Bid #1.
- 11. Add to Drawing E-102 General Notes #1: Contractor shall provide watt meter for gym feeder in south side electrical room equal to E-mon D-mon 4801600 KIT. Meter shall be mounted on wall adjacent to new pull section. Provide 20 amp, three pole, circuit breaker for meter in main switchgear. This work is part of Base Bid #3.
- 12. Add to Drawing E-102 General Notes #2: Contractor shall provide watt meter for gym feeder in south side electrical room equal to E-mon D-mon 4801600 KIT. Meter shall be mounted on wall adjacent to new pull section. Provide 20 amp, three pole, circuit breaker for meter in main switchgear. This work is part of Base Bid #4.
- 13. Add to Drawing E-103 General Notes #1: Contractor shall provide watt meter for feeder of panel 2EMP1 in south side electrical room equal to E-mon D-mon 480400 KIT. Meter shall be mounted on wall adjacent to panel 2EMP1. Provide 20 amp, three pole, circuit breaker for meter 2EMP1. This work is part of Base Bid #2.
