PROPERTY DECLARATIONS DUE BY NOV. 1

The Assessor's Office reminds all owners of businesses located in Glastonbury that the 2021 Personal Property declarations are due no later than NOVEMBER 1st at 4:30 PM. Detailed instructions can be found on the declaration, which are mailed in late September. Declarations are also available on the Assessor's web page.

PROPERTY TAX EXEMPTION FOR VETERANS

Honorably discharged veterans who have served a minimum of 90 days during wartime may be eligible for a Veteran's exemption, which would be applied to their real estate, or to a motor vehicle (if no real estate is owned). Proof of military service (original DD214 discharge document) must be filed with the Town Clerk's Office on or before Sept. 30, 2021 for application on the July 2022 tax bills. Disabled Veterans may receive an additional exemption based on their percentage of disability. Proof of disability needs to be filed only once with the Assessor's Office unless there has been a recent change in the disability rating. The original DD214 must also be filed with the Town. NOTICE ON TAILGATING FROM GLASTONBURY POLICE DEPT.

One of the leading causes of motor vehicle accidents in the United States is tailgating. Over the past three years, tailgating has been identified as the primary contributing factor in 29% of Glastonbury crashes, and Glastonbury Police have cited 389 drivers for tailgating violations. Connecticut law requires that vehicles be driven a reasonable distance apart, and drivers responsible for a rearend accident will usually be charged with this infraction. Drivers tailgating to harass, or due to road rage will be charged with a similar, but more serious misdemeanor offense.

A good rule of thumb is to remain 4 seconds behind the vehicle in front of you. To determine that distance, pick a reference point that the vehicle in front of you passes, and then count how long it takes you to pass that same point. If it is anything less than 4 seconds, you will not have enough time to react if that vehicle suddenly comes to a stop. Another tip is to distance your vehicle at least 1 car length for every 10 mph (e.g. 2 car lengths for 20 mph)

Many accidents can be avoided by reducing distractions and maintaining a safe distance between vehicles. During inclement weather, it is particularly important to increase your distance and decrease your speed. Plan ahead to give yourself plenty of time to get to your destination. This will reduce your stress and decrease the likelihood that you will engage in dangerous driving behavior. Please, do not drink and drive. Working together, we can keep Glastonbury roads safe and welcoming for everyone.
