## 1. Action on Public Hearings

A. Proposed 7 Lot Residential Subdivision- Sand Hill Estates 1040 Main Street Design and Construction of Sanitary Sewers

In accordance with Section 7-247a of the Connecticut General Statutes and Section 19-68 of the Town of Glastonbury's Code of Ordinances, the Glastonbury Water Pollution Control Authority will conduct a Public Hearing commencing at 6:00 p.m. on Wednesday, May 12, 2021, via Zoom video conferencing. At the hearing, the affected property owners shall have an opportunity to be heard concerning the proposed acquisition or construction of a sanitary sewer system and the estimated assessments therefor. Proposal is for the construction of approximately 600 L.F. of public sewer in conjunction with a new roadway to service eight (8) proposed residential building lots. The proposed sewer will be located within the Roaring Brook Watershed and be constructed as part of the proposed 8 Lot Residential Subdivision located at 1040 Main Street Glastonbury, Connecticut. Plans may be reviewed on the Town of Glastonbury website located on the calendar page, prior to said hearing.

Davis, Jr., Secretary The Chairman asked if anyone wanted to speak regarding this item, but no one came forward and no public comments were received by way of the Town of Glastonbury website. Ron Wolff, the Engineer representing Carrier Construction, Inc., informed the commission that the proposed subdivision was reduced from 8 to 7 lots, and clarified topography and grading inquires brought forth by the commission.

Mr. Davis MOVED that the Town of Glastonbury Water Pollution Control Authority APPROVE the design and construction of sanitary sewers for the proposed 7-lot subdivision at 1040 Main Street, Sand Hill Estates by Carrier Construction, Inc.

Mr. Tanski SECONDED the MOTION and it was unanimously approved.

- A. Sewer Use Subcommittee
  - 1. Subcommittee Recommendations
    Sewer Use billing policy and guidelines review

Mr. Bisi reviewed the revised Sewer Use billing policy and guidelines and felt there were areas that needed additional strengthening with regards to dates, and also to reinforce policy guidelines requiring meters to be permanently installed indoors versus removable outdoor meters. The Commission requested further clarification regarding where the interior meters should be installed. Mr. Bisi clarified that they need to be installed inside the structure as outdoor meters require winter removal and he stated that this creates vulnerability. The Commission requested clearer verbiage such as "within the structure on the property" be included in the policies and guidelines on any lines referring to installation requirements. The Commission also requested to review the finished guidelines before they are sent to property owners. Mr. Bisi mentioned that property owners were sent letters informing them of these new policies and guidelines and received substantial feedback from residents who had been unsure of special meter requirements. He also mentioned that there were 90 new meter installations in the past year with approximately 1293 special-metered accounts to-date. Mr. Bisi also mentioned that they have resumed inspecting and tagging new meters. He will provide the second revision within the packet at the next commission meeting scheduled for July 14th.

Mr. Davis MOVED that the Town of Glastonbury Water Pollution Control Authority APPROVE subcommittee's recommendations regarding Sewer Use appeal billing policies and guideline revisions.

Mr. Tanski SECONDED the MOTION and it was unanimously approved.
