Mr. Davis MOVED that the Town of Glastonbury Water Pollution Control Authority APPROVE Resolution 2020-11, Supplemental Assessment of Benefits #938 for 2407 Main Street – Town of Glastonbury – Welles-Turner Memorial Library.

Mr. Campbell SECONDED the MOTION and it was unanimously APPROVED.

3. Developments

A. 83 Naubuc Avenue – Corrine Crocker-Luby and William Luby Sanitary Sewer Impact Report (RP Engineering, Inc. - Engineers) Corrine Crocker-Luby

Corinne Crocker-Luby spoke, referring to the Sanitary Sewer Impact Report that RP Engineering prepared. She read that the property is in the Town Center Mixed Use Zone and the building is 1,942 square feet. The proposal will increase the square footage to 4,995. The parcel is 0.494 acres. She is proposing a 150-seat restaurant, with 9 hours a day of operation at most, and a 2-bedroom apartment on the second floor. The initial intent is to hold events on the weekend. She said the anticipated flow for both uses is 945 gpd with a peak flow of 2,552 gpd. The engineer has designed an exterior grease trap to meet the State's Health Code and the Town's Building Code, with a capacity of 2,000 gallons.

A member asked if Mr. Mahoney had any issues. Mr. Mahoney responded no, the flow capacity is less than expected according to the Master Sewer Plan.

Mr. Davis MOVED that the Town of Glastonbury Water Pollution Control Authority APPROVE the Sanitary Sewer Impact Report for 83 Naubuc Avenue – Corinne Crocker-Luby and William Luby.

Mr. Tanski SECONDED the MOTION and it was unanimously APPROVED.

Mike Bisi spoke, saying they were finalizing their bill processing and bills are on schedule to go out on November 1. He thinks they have straightened out the new MDC account numbers, so they are in good shape.

B. Correspondence

1. Memorandum to Revenue Collector – 2020 Sewer Use Rates\

The members reviewed the memorandum; as the rates did not change, a vote was not necessary.

3. Sewer COVID19 testing

Mike Bisi asked to add this item to the agenda. He told members that, according to the Glastonbury Citizen, at the last Town Council meeting, information was requested regarding potentially testing wastewater for COVID19. He mentioned that Yale is doing a study with the city of New Haven and the MDC is working with UConn. He said this is happening in many places across the US and is not totally new; using wastewater for surveillance of a number of things has been going on for a number of years. He added that the Health Director and he had put some information together for the Town Manager who presented it to the Town Council last night to see if they would be willing to fund such a program. This sort of study could cost \$5,000 to \$6,000 a month, with the lab analysis being the biggest expense. Council members discussed the idea, but it was thought to be too great an expense. Mr. Bisi said it would really be a project for Health Department oversight.

Mr. Carlson asked if, during their discussion, if the Council considered what would be done with the data? Mr. Bisi said yes, they questioned what they would do with the data if a spike was seen, as the data could possibly start a panic.

Mr. Bisi added the Council did vote on the matter and the approval was denied as they thought was the costs were too great.

Mr. Davis MOVED to adjourn the meeting.

Mr. Tanski SECONDED the MOTION and it was unanimously APPROVED.

The meeting ADJOURNED at 7:24 p.m.
