# • Minnechaug Golf Course/Restaurant Update:

Lisa Zerio stated that through September 16, of this year 18,373 rounds of golf have been played. Compared to last year at this time they are down over 3,000, but almost 10,000 rounds more than 2019. Considering the very wet summer, the course is having a great year, and the restaurant is doing well.

#### Fall Concert:
