The Town typically allocates \$325,000 annually for the sidewalk repair program, portions of which may be awarded to multiple vendors as described in Special Conditions Section 2.0 Basis of Award. **In order to account for the variability in the contract award amount, the Performance and Payment Bond unit cost must be included in Item 16 of the Bid Proposal Form.** The unit price for this item is to be computed as the dollar value of the bond per thousand dollars (\$1,000) of contract value. For example: \$10.00 per \$1,000 of Contract Value.

QUESTION AND ANSWER:

Question 1: In Special Condition Section 1.02, page SC-1 of the bid documents it states that the contractor will be assigned sidewalk repair work neighborhood by neighborhood. Can you provide an estimate of the amount of work done per street/neighborhood?

Answer: The amount of sidewalk repair work to be performed in each neighborhood under this contract varies, however the majority of neighborhoods to be assigned have significant sidewalk deterioration to be addressed. The Town makes every effort to ensure that sidewalk repairs in a particular neighborhood or work area are grouped together in such a way as to allow a full load of concrete to be utilized. However there will be rare situations where a small section of concrete walk needs to be replaced in an area of Town where no other sidewalk work is required. In these situations additional costs related to short load fees shall be the responsibility of the Contractor.

Question 2: We are interested in bidding on your Annual Sidewalk Program and were hoping you could send me past years bid tabulations if possible.

Answer: The recap from the last solicitation has been included as part of this Addendum.
