SUBJECT: ADMINISTRATIVE NOTIFICATIONS

#### Section I - Introduction

# A. Objective

To identify certain incidents in which the Department's Duty Officer, Assistant Chief and Fire Chief shall be immediately notified by the Department's Dispatch Center.

## B. Applicability

Fire Alarm Dispatchers shall promptly notify the Duty Officer, Assistant Chief and Chief of the Department for any of the circumstances detailed in this guideline.

#### Section II - General

Notifications shall generally be made via Fire Department radio, cell phone or home phone.

Specific request by an Officer for a single resource (FMO to scene for non-working incident)

"Heads-up" type notifications can be made via email (very minor Department vehicle accident against Fire Department property or "Injury" notification of non Fire Department non-active town employee")
