Section I - Introduction

A. Objective

To identify how and when the Department participates, in response to the Statewide Fire Rescue Disaster Plan.

This guideline applies based on the activation of Task Force 57.

Section II - Guideline

Through participation in the Statewide Fire Rescue Disaster Plan this Department has committed resources for response to disaster emergencies.

COMMITMENT

Glastonbury, when in receipt of notification from a County Fire Coordinator of an expanding incident with regional impact, will respond initially with a minimum of four (4) personnel, one of which will be an Officer. As soon as practical an additional Glastonbury Officer, preferably a Deputy Chief or Captain will respond as a Command level status and report to the Incident Command Post.

CREPC REGIONAL EMERGENCY SUPPORT PLAN

The purpose of CREPC Regional Emergency Support Plan is to provide a framework for Capitol Region Emergency Planning Committees (CREPC) member municipalities, the State of Connecticut, the federal government, public agencies, the private sector, volunteer organizations, medical facilities, schools and universities to collaborate in planning, communications, information sharing and coordination activities before, during or after a regional emergency.

The Regional Emergency Support Plan is designed, through formation and activation of up to sixteen (16)
Emergency Support Function (ESF) committees to provide regional support for all conceivable functions that may be required at a complex and long term regional emergency.

The ESF's available to any CREPC municipality are ESF-1-Tansportation; ESF-2- Communications; ESF-3- Public Works and Engineering; ESF-4-Fire; ESF-5-Information& Planning; ESF-6-Mass Care; ESF-7-Resource Support; ESF-8-Health & Medical Services; ESF-9-Urban Search & Rescue; ESF-10-Hazardous Materials; ESF-11-Food; ESF-12-Emergency; ESF-14-Media; ESF-15-Donations and Volunteer Management; ESF-16-Law Enforcement and ESF-17-Animal Protection.

Events may impact only one (1) ESF or have crosscutting implications for many ESF's Each ESF is responsible for having the capacity to coordinate the aspects of any event that falls within their ESF area of responsibility. ESF's are prepared to offer not only operational assistance but also to provide information to decision makers and to make recommendations.

REQUESTING REGIONAL EMERGENCY SUPPORT PLAN ACTIVATION FOR GLASTONBURY

When an incident takes place that affect Glastonbury, the Incident Commander or EOC, if activated, will review the situation and size up the requirements to successfully mitigate the event. If the event is of significant nature the IC or EOC shall notify Tolland County Dispatch by calling via telephone (860-875-2543) and advise of the type of action requested. The action could range from advisory notification only up to full activation of the Regional Emergency Support Plan. Tolland County Dispatch will notify the county coordinator of each ESF of the situation/event and cause response if required.

WHEN TO ACTIVATE REGIONAL EMERGENCY SUPPORT PLAN

IC or EOC can activate the Regional Emergency Support Plan for a sudden, very serious or extreme incident that has a regional impact or after normal mutual-aid has been depleted.
