The ordinance enabling this exemption requires that:

The application shall include at least two affidavits of disinterested persons showing that the deceased child or person was performing such active military duty, that such deceased child or person was killed in action while performing such active military duty and the relationship of such deceased child to such parent, or such deceased person to such surviving spouse, provided that the Assessor may further require such parent or surviving spouse to be examined by such Assessor under oath concerning such facts.

The affidavits required in section (c)(1) shall be recorded in the Glastonbury Town Clerk's office, free of charge, and such recording shall list the name of such parent or surviving spouse claiming the exemption. No exemption shall be granted unless the affidavits have been recorded in the Town Clerk's office and until the application has been deemed complete by the Assessor.

Your completed application **must be received by October 1st in the Assessor's Office**. The Assessor's Office and the Town Clerk's Office are located on the ground floor of the Glastonbury Town Hall at 2155 Main Street, Glastonbury, Connecticut. The Glastonbury Town Hall is open Mondays through Fridays from 8:00 AM to 4:30 PM.
