A. Sewer Use Rates Resolution 2022-15

In accordance with Section 7-255 of the Connecticut General Statutes, the Glastonbury Water Pollution Control Authority will conduct a public hearing commencing at 6:00 p.m. on Wednesday, October 12, 2022, in the Glastonbury Town Hall, 2155 Main Street, Glastonbury, Connecticut. At the hearing, affected property owners shall have an opportunity to be heard concerning the proposed sewer use rates:

- 1. \$ 3.30 per ccf for 100 percent of metered flows.
- 2. \$ 3.30 per ccf for non-metered flow of 140 ccf.
- 3. \$ 0.075 per gallon of septic sewage.
- 4. \$20.00 surcharge for processing special metered accounts
- 5. \$60.00 minimum bill/standby charge.

5. Acceptance of Minutes

A. Regular Meeting- August 10, 2022

Mr. Davis MOVED, that the Town of Glastonbury Water Pollution Control Authority APPROVE the Minutes for the Regular Meeting of August 10, 2022.

Mr. Campbell SECONDED the MOTION and it was **APPROVED 4-0** with Chair vote. Mr. Tanksi, Mr. Lawlor and Mr. Comerford abstained.

B. Regular Meeting & Public Hearings- September 14, 2022

Mr. Davis MOVED, that the Town of Glastonbury Water Pollution Control Authority APPROVE the Minutes for the Regular Meeting & Public Hearing of September 14, 2022.

Mr. Campbell SECONDED the MOTION and it was APPROVED 6-0, Mr. Davis abstained.

6. Other Business Properly to Come Before the Authority

A. Memo from Mike Bisi- Former Sanitation Superintendent- Budget Transfer- Water Pollution Control Facility Roofing Work

Mr. Bisi referenced contents of the memorandum included in packet Item 6.A regarding a budget transfer for roofing work at the Water Pollution Control Facility. He explained and clarified details of the transfer and wanted to ensure this went on record. Mr. Bisi also reassured the Commission that the Town Manager was made aware of these details.

Mr. Bisi introduced his successor, Mike Manfre, and briefed the Commission on his work history in the field. He expressed sincere confidence in Mr. Manfre's capabilities and explained that he will remain full time until the end of October to assist with the transition.

Mr. Mahoney addressed the Commission explaining Public Act No. 21-29 that the Town Plan and Zoning Commission informed him of for accessory dwelling units. He noted that if the Water Pollution Control Authority does not opt out of this public act, they will be unable to assess these accessory dwellings. Mr. Mahoney noted that the Plan and Zoning Commission chose to opt out. He plans to present a resolution at the November meeting and suggests that the WPCA opts out as well. It would then be proposed at the Town Council's December meeting in an effort to meet the State's January 1, 2023 opt out deadline.

At the Commission's request, Mr. Mahoney clarified the Plan and Zoning Commission's current special permit process for accessory dwelling units and explained that their decision to opt out was to maintain regulatory control under their current regulations. He noted that if the WPCA does not opt out, supplemental sewer connection fees for these dwellings cannot be charged to property owners.

Mr. Accornero MOVED to adjourn the meeting.

Mr. Comerford SECONDED the MOTION and it was APPROVED unanimously.

The meeting ADJOURNED at 6:18 p.m.
