## November 8, 2022 State Election

The Electors of the Town of Glastonbury are hereby warned to meet at their respective polling places in said town on Tuesday, November 8, 2022 for the following purposes:

- I. To cast their votes for Governor and Lieutenant Governor, United States Senator, Representative in Congress, State Senator, State Representative, Secretary of the State, Treasurer, Comptroller, Attorney General, Judge of Probate and Registrar of Voters.
- II. To vote on the following question for the approval or disapproval of a proposed AMENDMENT to the Constitution of Connecticut, a vote of "YES" being a vote for approval, and a vote of "NO" being a vote for disapproval:

1. Shall the Constitution of the State be amended to permit the General Assembly to provide for early voting?

The full text of such proposed questions with explanatory text, printed in accordance with §2-30a of the General Statutes, is available at the town clerk's office for public distribution.

The vote on the proposed question is taken pursuant to the Constitution of Connecticut.

III. To vote on the following town question for the approval or disapproval, a vote of "YES" being a vote for approval, and a vote of "NO" being a vote for disapproval:

1. Shall the Town of Glastonbury appropriate \$3,000,000 for the purchase of development rights and acquisition of land pursuant to the ordinance establishing the Town's reserve for land acquisition and authorize the issue of bonds and notes in the same amount to finance said appropriation?

The full text of such question with explanatory text, printed in accordance with §9-369b, is available at the Town Clerk's Office for public inspection.

The vote on the proposed question is taken pursuant to Sec. 312 of the Glastonbury Town Charter.
