- **Citizen Newspaper Request for Support-** Lisa stated the Citizen has been looking into eventually offering online to subscribers. The Citizen offered to give the Senior Center a PDF file for viewing at the Center for those interested. Lisa also advised the Commission that the Citizen reached out to ask if the Department would be interested in doing a monthly article. Patti is working with the editor on specifics.
- **Inclusionary Zoning Ordinance-** Denise recapped the proposed ordinance and suggested that a letter from the Commission be sent before TPZ meets to discuss and take action.
- **Oak Tree on Tryon Street-** The signage near the tree has been effective and getting feedback that it is working. Staff will work with engineering on the placement of boulders, and an Age Friendly bench will be placed in the Spring.
