The following will keep you up to date on various topics.

1. **COVID Report**

The October 18th report is attached.

2. **Expense Report**

A copy of my expense report for the three months July through September 2022 was forwarded separately. I will appreciate Council recognizing receipt of this report on Tuesday evening.

3. **Spooky Stroll**

The Library and Recreation Department sponsored the annual Spooky Story Stroll between 3:00 and 7:00 p.m. on Wednesday, October 19th. Young people went on a "stroll" at the RCC and Riverfront Park with stops along the route for stories and a bagged treat at the end of the stroll. There were 527 participants. Thanks to Council Member McChesney for again participating as a reader this year.

This year's event also offered a flu and COVID vaccination clinic with 103 adults receiving their flu shot and 64 adults and 14 infant/pediatric receiving their COVID shot.

Great job by all.

4. **COVID and Flu Vaccination Clinic**

A final "get vaccinated against COVID and flu now and be fully protected for Thanksgiving" vaccination clinic is scheduled for November 1, also at the RCC.

5. **Community Workshop – Design Guidelines**

A community workshop for the Town Center Design Guidelines is scheduled for Wednesday, November 16th at 6:00 p.m. at the Riverfront Community Center. This will allow for a review of project scope and status and opportunity for public comment to assist with the ongoing process.

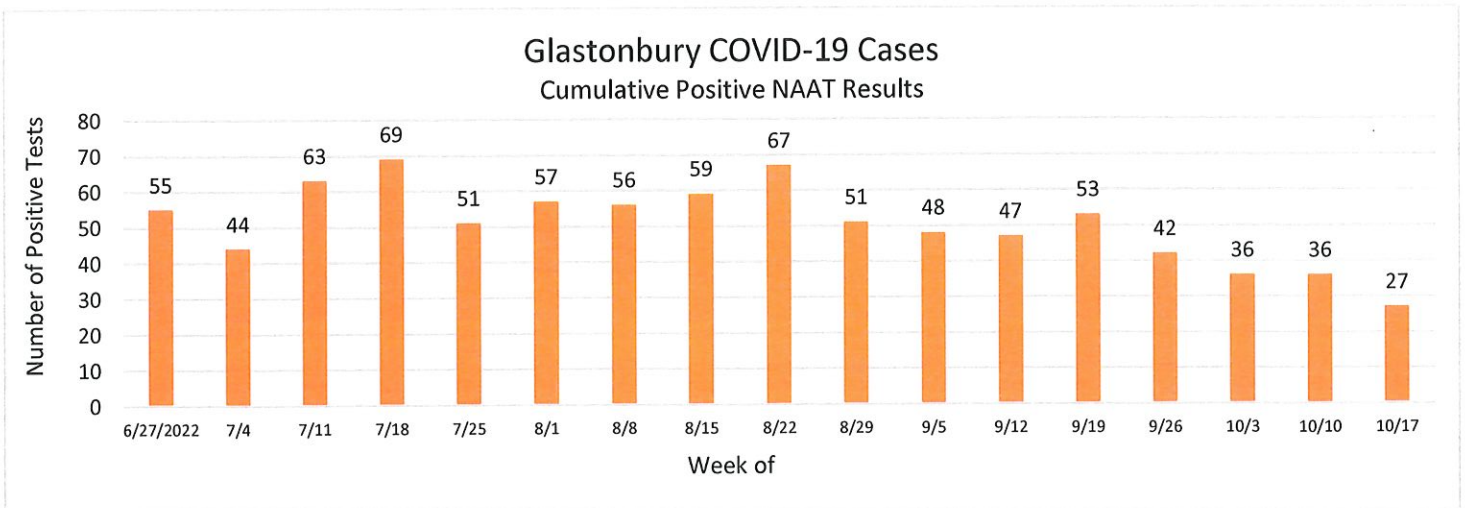
Re: COVID-19 update

Connecticut Department of Public Health (CT DPH) has recently revised how COVID-19 data is presented. Publicly available datasets previously used to populate charts and graphs for Glastonbury’s weekly COVID-19 reports are no longer available, and data from the new systems are not directly comparable to old systems. 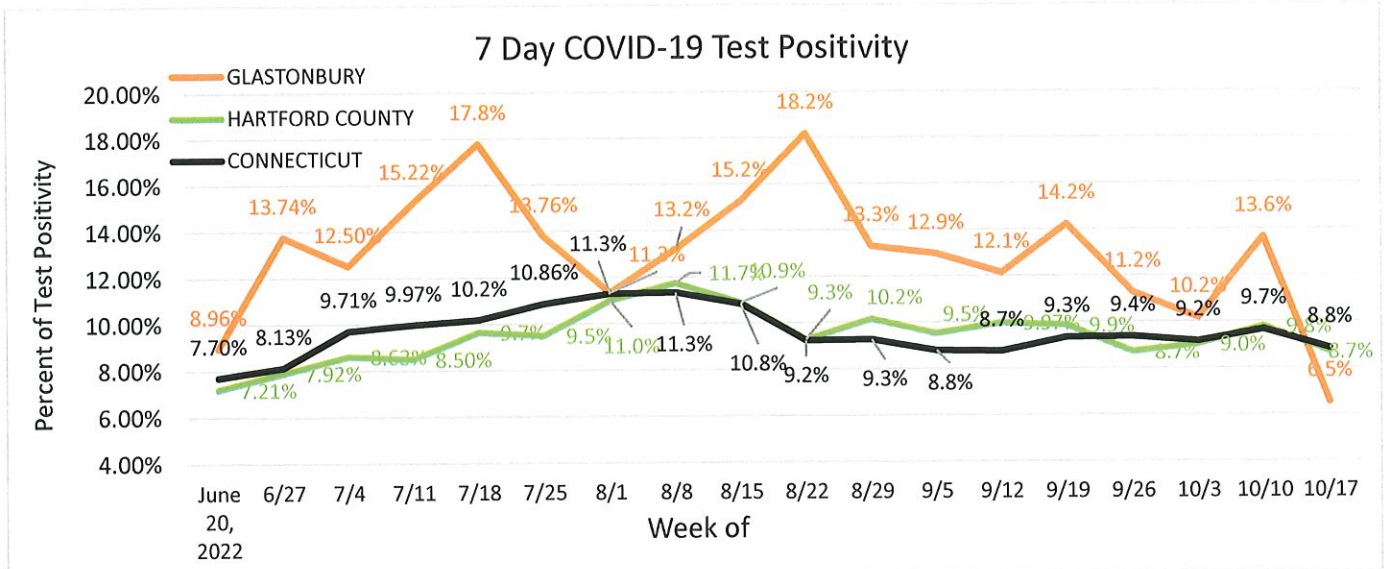
This report contains data from laboratory-confirmed results. At home tests are not included in this data, so information and graphs demonstrate trends rather than a full accounting of cases. Numbers in (parentheses) indicate change from the previous week.

As per CT Department of Public Health data from October 17, 2022:

- A total of 132,215 tests have been administered to Glastonbury residents. (+305)
- Of the 132,215 tests administered, 7,378 were laboratory positive NAAT cases. (+27)
- No additional deaths were recorded this week. The loss of Glastonbury residents remains at 119. (+0)



Test positivity is calculated as a rolling 7-day test positivity by specimen collection date; all positive molecular (PCR/NAAT) test results are divided by all molecular (PCR/NAAT) test results (positive and negative) for the last 7 days and multiplied by 100 to reach a percentage. Results are shown below for Glastonbury, Hartford County, and the state of Connecticut overall.



COVID-19 Vaccine update

The COVID-19 booster vaccine available this fall is specifically tailored to combat the two most prevalent omicron subvariants, BA.4 and BA.5. A person is eligible for a booster if it has been at least two months since their last COVID-19 vaccine (whether the primary series or any booster). The Moderna booster shot is approved for people ages 6 years and older and the Pfizer-BioNTech vaccine is authorized for people ages 5 years and older.
