Furthermore, they get some of their information from manufacturers, who cannot be relied on to provide unbiased data. After hearing all the testimony and evidence, if there is reasonable doubt in your mind about the safety of artificial turf, then please vote AGAINST replacing grass with artificial turf. Following are three factors that carry more weight than student experience. (1) Health Risks: Some artificial turf products contain toxic chemicals such as lead and mercury, which can pose health risks to players and users, especially children who are more vulnerable to the effects of these chemicals. These chemicals can be released from the rubber infill used in artificial turf, which can be ingested or inhaled during play or maintenance activities. In addition, artificial turf can get hot in direct sunlight, increasing the risk of heat-related illnesses. (2) Increased Risk of Injuries: Compared to natural grass, artificial turf is harder and less forgiving, which can increase the risk of injuries such as concussions, ankle sprains, and knee injuries. Most know that PFAS (pre- and polyfluoroalkyl substances) are a class of chemicals known to harm human health, causing cancer and other serious medical problems. Many may not know that AT fields are made up of 40,000 pounds of PFAS containing plastic. The plastic in this type of field turf is made from fossil fuels, the fabrication of which contributes to greenhouse gasses. For the sake of the health of our young people and others who use the fields of AT put at risk by playing sports on such artificial turf most parents would not want their children to be exposed to this risk. In addition, environmental considerations militate against such AT fields because they degrade and generate micro-plastic that is released in the environment. Moreover, Using this type of artificial turf is neither economically nor environmentally beneficial. AF fields have a short span of utility of only 8 – 10 years before needing replacement and the fields cannot be recycled. It is fiscally irresponsible to spend 1.5 million dollars per field and high future replacement costs.
