- 3. **MINUTES** of the February 6, 2023, regular meeting were approved as presented.
- 4. **DEPARTMENTAL REPORTS** were submitted in the packets. Phil inquired as to what was the Memory Screening program. Gayle summarized what the program was about. Lisa sent the Commission follow up information on the program: It is a free, confidential memory screening. These confidential memory screenings average 15 minutes and consist of questions and tasks to assess memory. They do not diagnose any illness, but can indicate whether someone should follow up with a full medical exam. Sponsored by Hartford HealthCare Center for Healthy Aging. Screenings are done on the first Wednesday of each month from 10:30 to 11:30 am. Pre-registration is required.

Age-Friendly Community Initiative

Housing Subcommittee- Gayle advised that committee met on Friday, February 17th.
