YOU WILL NOT BE ABLE TO PARTICIPATE IN THE MEET IF THE PARKS AND RECREATION DEPARTMENT DOES NOT HAVE YOUR FORM BY THE DEADLINE! Once forms are submitted, no changes are allowed.**
- TRANSPORTATION:** Parents are responsible for their child's transportation. Parental supervision is required.

ABOUT HERSHEY TRACK AND FIELD

Program is designed for the beginning athlete and stresses participation, enjoyment, and physical exercise. The results for the top finishers in each event at the local meet will be compared to the top finishers at other local meets in the district. **The top four finishers in each event from the district will advance to the State meet.** Participants will be notified the week of Monday, June 10th, if they qualified for the State Meet. Winners of the State Meet have the opportunity to advance to the National Final in Hershey, PA* (Not every winner at the State Meet will go the National Final due to the geographical distribution rule.) Sponsored by the Connecticut Recreation and Parks Association.

*The 9-10 and 11-12, 4x100 relay, will not advance to the North American Final this year. Those age groups will be allowed to participate in the relay as an extra event at the local and state meet level.

- STATE MEET:** The State Final is scheduled for Saturday, June 22
Willow Brook Park, New Britain
- NATIONAL MEET:** The National Final is scheduled for August 3
in Hershey, Pennsylvania.
