**Re: Proposed New Sidewalk Construction – Bell Street**

Dear Property Owner:

The Glastonbury Town Council has scheduled a public hearing for 8:00 p.m. on Tuesday, July 25, 2023 to consider proposed construction of new sidewalks along portions of Bell Street between Bellridge Road and Gideon Lane and at the corner of Bell Street and Hebron Avenue. The cost to construct the sidewalks is estimated at \$1,000,000, of which \$600,000 will be reimbursed by a State Community Connectivity Grant. The balance would be funded through the Town's capital budget. Pending state approval, bid results, and weather, it is anticipated that construction would begin this season and end in the spring of 2024.

The proposed plan is shown on the reverse side of this letter with new sidewalk areas highlighted in red and outlined with black boxes. More detailed plans can be viewed at the following link:



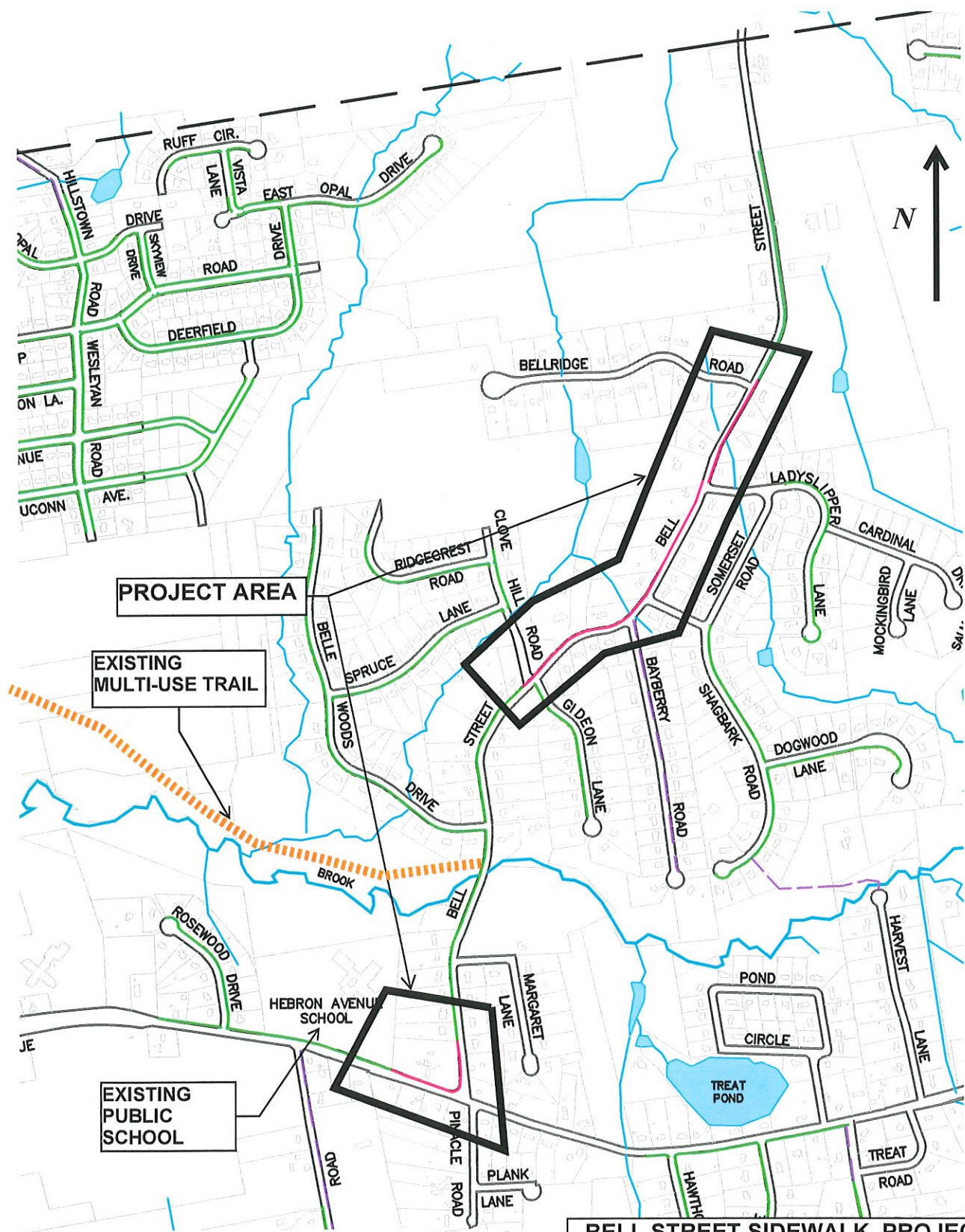
