Age Friendly Community Initiative

Housing Subcommittee: Gayle and Denise met with the committee which has two new members Chris Nicholaou and Jan Baldinger. Neil Griffin is putting together a resource guide. Denise discussed the volunteer chores program and ideas for providing assistance for people who are looking for people to hire for small jobs and willing to pay. Currently, our program only has 3 volunteers and they are mostly doing companionship rather than chore service. Ronda shared her experience working with a contracted agency to assist with heavy chore cleaning. A grant paid the fees and clients were charged based on a sliding scale. Denise reiterated the importance of evaluating and supporting zoning laws that support inclusionary housing, universal design, ADU's.

Transportation Subcommittee: Beth reported the committee met twice over the summer. She will send a revised draft letter that will be sent to Dan Pennington, Town Engineer to the Commission for review and comments. The committee is made up of members of the local walking group and the bike advisory group. The committee has identified and are recommending safety improvements that would make the roadways more accessible to walkers, runners and bicyclists.
