The attention of bidders submitting proposals for the above-referenced project is called to the following Addendum to the specifications. The items set forth herein, whether of omission, addition, substitution or other change, are all to be included in and form a part of the proposed Contract Documents for the work. Bidders shall acknowledge this Addendum in the Bid Proposal by inserting its number on Page BP-1.

Make the following modifications to the Contract Documents:

BID PROPOSAL FORM:

The bid proposal form is hereby replaced with the attached. ALL BIDDERS <u>MUST</u> USE THE REVISED BID PROPOSAL FORM.

QUESTIONS AND ANSWERS

Page 15 mentions the relocation of CNG Gas, Eversource Poles & Wires, & Frontier Wires. Q1-1: What is the current status? Any other wires involved i.e. cable TV? Has any of this work been accomplished yet or is scheduled? Required utility relocation work by others is described in the project plans and specifications A1-1: and includes the relocation of 5 utility poles, 3 fire hydrants, offset of a gas main, and adjustment of several telephone manholes. The Town has been coordinating with the various utilities with the goal of having the relocation of these items completed prior to the start of construction in April of 2024. Any utility relocation work by others that is not completed by the time construction starts will need to be coordinated with and by the contractor during the project work. The project has 120 calendar days, but Item 1131032A Changeable Message Signs quantity Q2-1: is 180 Days. Does this mean 2 signs will be used during the project, or will the sign to be there before/after the calendar days of the project? A2-1: Two CMS signs are required at the project limits for the duration. A new bid form is attached to this addendum that revises the number of calendar days for this item to 250 days to allow the sigs to be installed in advance of construction startup. All bidders must use the revised bid form as part of their response. Q3-1: Our granite suppliers are telling us that there are not details to go along with each of the bid items for the curbing. They say they need the detail in order to quote the price. Granite curb details are included on Sheets 2 and 3 of the construction plans. All granite A3-1: curb other than the mountable curb is rectangular in shape and to the dimensions indicated in the details and pay items. The mountable curb is shown on sheet 2, with the 20" dimension referring to the height at the back of the curb. The top is sloped to provide 1.5" reveal, making the front measurement of the curb 18.5".
