A. 330 Naubuc Avenue- Naubuc Ave LLC Sanitary Sewer Impact Report (James Dutton- Dutton Associates, LLC)

James "Jim" Dutton of Dutton Associates, LLC came forward and was representing owners Rick and Mary Damato (Damato Realty Group, LLC) of 330 Naubuc Avenue. Mr. Dutton gave a brief history of the use of the building- originally built as daycare, then converted to a church, and now it is being proposed as a Chiropractic Office and Spa. Mr. Dutton stated that the Business Plan is accounting for a maximum of 90 people per day and they predict each person would shower during their visit. Mr. Dutton stated that he utilized the Connecticut Public Health Code criteria for the Swimming Pools, which calculates 10 gallons per shower. Therefore, the estimated flow calculated is 21,032 gallons per day (GPD) with peak flow of 57,000 GPD. The Master Sewer Plan Criteria allows for 25,012 GPD with peak flow 67,083 GPD. The estimated flow proposed is below Master Sewer Plan Criteria. Mr. Dutton mentioned that an addition is proposed for the Spa which includes pools, showers and a sauna.

Mr. Comerford MOVED, that the Glastonbury Water Pollution Control Authority APPROVE the Sanitary Sewer Impact Report for 330 Naubuc Avenue.
