Town Manager's Report

Dear Council Members:

The following will keep you up to date on various topics.

1. Weekly Update from Glastonbury Emergency Medical Services

Attached are recent weekly updates from GEMS.

2. Glastonbury At A Glance

The July 2024 edition of the Town's monthly newsletter is attached.

3. Elderly Homeowner's Tax Credit Program

The attached memorandum summarizes tax credits granted under the State and Local Elderly Tax Relief Program. The tax credit is provided through the state mandated program and supplemented by additional income limits and credits through local ordinance. The income limits and credits are adjusted administratively per the process established by the Town Code.

4. Transportation Alternatives Set-Aside Program 2024 Project Solicitation

The Capitol Region Council of Governments (CRCOG) invited eligible communities to submit proposals for projects to be funded under the Transportation Alternatives Program (TAP). Eligible projects included: on-and off-road pedestrian and bicycle facilities, infrastructure projects for improving non-driver access to public transportation and enhanced mobility, community improvement activities, multi-use trail projects, and safe routes to school projects. CRCOG received and reviewed seven project applications, including a \$2.4 million project from Glastonbury entitled "Hebron Avenue Sidewalk Installation and Multi-Use Path Rehabilitation." This is the same project that the Town Council authorized staff to submit to the TAP at the Council meeting held April 23, 2024. CRCOG staff ranked Glastonbury's project fifth – enough to make the cutoff for anticipated future funding. CROCG, Glastonbury and the other communities that made the cut will now wait to see if Congress will fund the TAP. CRCOG staff advises that Congressional funding could take a few years. In the meantime, town engineering staff will begin chipping away at project design.

5. ARPA Grant for Senior Center Facility Improvement

This spring, the Board of Finance and the Town Council granted staff's request for a \$91,967 appropriation and transfer from the Capital Reserve Fund to a Capital Improvement Project Fund entitled "ARPA Senior Center Facility Improvement Grant." Staff recommended those actions in anticipation of the Town being awarded a \$91,967 reimbursable grant from the State for the benefit of our senior center facilities. As a result of the State's most recent legislative session, several towns will receive reduced grant awards or no grant awards at all. The State recently informed the Town that it would receive the full grant amount of \$91,967 since the Town submitted its grant paperwork to the State prior to the close of the legislative session. Staff will now move ahead with the project, which includes the creation of a fitness center, lobby enhancements, and café improvements.

6. Ribbon Cutting Ceremony at Naubuc School

Councilors are invited to attend an August 28th ribbon cutting ceremony at 8 a.m. at Naubuc School to celebrate the completion of the Classroom Reconfiguration project. Please let me know if you plan on attending.

7. Connecticut River Hydrilla Control Research and Demonstration Project

The US Army Corps of Engineers (USACE) New England District has updated its summer schedule for the 2024 CT River hydrilla aquatic herbicide treatment project. USACE will begin to treat hydrilla at Keeney Cove from July 22nd through July 26th. 8. Algonquin Gas Transmission Performing Routine Work Near Thompson Street

Algonquin Gas Transmission, owned and operated by Enbridge, plans to perform routine maintenance work along a segment of its pipeline off (to the east of) Thompson Street. This work is being performed for the continued safe and reliable operation of the interstate natural gas system. The project is expected to start on July 8, 2024 and last approximately three weeks. During this time, travel on Thompson Street near the intersection with Chimney Sweep Hill Road may experience periodic short delays during normal work hours of 7:00 AM to 5:00 PM, Monday through Saturday, to support the delivery and removal of materials and equipment. These delays will take place primarily at the commencement and conclusion of their work on site. Once on site, Algonquin's planned maintenance work will take place between the hours of 7:00 AM to 5:00 PM, Monday through Saturday over those three weeks and will not interrupt any utility services for area residents.

9. Farm Assistance Program Grant

The Town began accepting applications for the Farm Assistance Grant Program on May 31, 2024. July 1, 2024 was the deadline for farms to submit letters of intent to apply for the grant. As of July 2nd, the Town received 16 letters of intent. Any letters received hereafter will not be eligible for funding. To date, the Town has also received grant applications from 4 farm businesses. The deadline for applications is October 31, 2024. Town staff will now begin reviewing applications and award funding on a rolling basis. The Town Council allocated \$220,000 of ARPA funding for this program. With 16 letters of intent received, the maximum amount of grant awards that could be issued by the Town would be \$160,000. Therefore, at least \$60,000 of program funding could be reappropriated for other projects. Below is a summary of the marketing and outreach efforts my office conducted.

10. Williams Memorial / Academy Building Hazmat Abatement

Abatement of hazardous materials has begun. Work is being performed by an experienced, licensed contractor. The Town has also engaged the engineering firm of Fuss & O'Neill to provide daily monitoring of containment barriers and air quality. Final testing will be performed by an independent laboratory. The abatement work is expected to last well into August. Generally, the work will begin on the 3rd floor of the Williams Memorial Building, and then continue into the Main Hall, and then continue in the Teen Center and finally in the hallway near the Academy Gym. The abatement work will have minimal impact on staff and patrons. Abatement activities near the Academy Gym are set for the two-week period in August when the gymnasts are on a scheduled break. The Teen Center has been temporarily relocated to the Academy Cafeteria.

11. MLK Mural Update

Mural painting on the exterior of the Town Hall is scheduled to start the last week of July and finish August 12th.

12. Town of Manchester to Replace In-Service Water Main Valves and Fittings in Glastonbury

The Town of Manchester's Water Department has selected Correia Excavators to do the following work:

- Replace approximately 385 linear feet of in-service water main along Route 83 (Manchester Road) in the vicinity of its intersection at Mountain Road.
- Replace existing in-service butterfly valves and gate valves with new resilient wedge gate valves located along Route 83 (Manchester Road) and Route 94 (Hebron Avenue). The valves identified have either failed or are at the end of service life.
- Install resilient wedge gate valves at new locations, fire hydrant, abandonment of existing water utilities, temporary and permanent pavement repair, and traffic control.

The Glastonbury Service Area generally includes neighborhoods along the Route 83 (Manchester Road) corridor extending from the Town line southerly to Route 94 (Hebron Avenue). The entire project is to be completed within sixty working days. It is anticipated that the work taking place in Glastonbury will take four days to complete. The contractor is targeting the week of July 15th or 22nd to perform the Glastonbury work. Work will take place from 10 PM to 5 AM. While work is taking place, water will be shut off to all Manchester Water Department customers. Customers are asked to refrain from using water during the shutdown time periods. The project will also require an alternating one lane traffic pattern on Manchester Road in the area adjacent to active construction work, at spot locations from the town line to Hebron Avenue. Some Glastonbury residents will be affected less than others. For example, residents located closer to the town line might only be impacted for one day, while those along Weir Street might be impacted for four days. The Glastonbury Fire Department has begun making plans to deal with fire hydrants being unavailable. The Glastonbury Health Department is determining whether or not it needs to inspect two area restaurants to ensure that post-project the water is not an issue. The Glastonbury Fire Department is considering using town electronic variable message boards to help ensure that impacted Glastonbury residents are aware of the project.

13. Police Department Seeks to Purchase Two Gates

The Glastonbury Police Department seeks to purchase two new gates. One gate would be located at the southwest entrance. The other gate would be installed at the east entrance. Attached are photos of the proposed gates. I have also attached an image that shows the proposed locations of the two gates. The gate to be installed at the southwest entrance would replace a gate that was recently removed due to mechanical failure. The gate would serve the purpose of mitigating vehicle/vehicle conflict as well as pedestrian/vehicle conflict. The gate to be installed at the east entrance would prevent unauthorized vehicular access to the Police facility. The cost of the two gates, including installation, would be \$31,507. There are sufficient funds to cover the expense in an existing capital account entitled "Police Site Renovations." It is my intent to approve the purchase of the two gates absent objection from the Town Council. The Council has spent a considerable amount of time the past year discussing walkability at the police department site.

14. Updates to the 2024 Road Paving List

The Town Engineer has again updated the 2024 Road Paving list. Millstone Road and Candlelight Drive have been removed because the Town recently learned that Connecticut Natural Gas plans to perform considerable work on those streets this fall, including the replacement of approximately 900 feet of gas main. In addition, there appears to be an MDC water leak in the vicinity. We anticipate MDC will eventually locate and repair the leak. Below is an updated list, which now includes Farmstead Lane, Ridge Road, and Tamarack Drive.

15. Capital Projects Report

A capital projects report will be available on Monday on the Town's website which will be good through June 30, 2024.

16. Forestry Inventory Project

At the previous Town Council Meeting, Councilors asked several questions about the Forestry Inventory Project and how that relates to a more comprehensive Forest Action Plan. Below is detailed information in response to these questions.

- The Forest Action Plan would help the Town with future forest and open space planning and resource allocation. In other words, the Plan would provide recommendations for how to best manage the forests over the next 10-20 years to achieve the Town's goals as stated in the Plan of Conservation and Development (POCD) and directed by the Council. These recommendations would be referenced during the preparation of budgets and workplans to ensure alignment in spending and staffing allocation to achieve the Town's forestry goals in balance with other Town priorities.
- The Forest Action Plan would build upon the open space management plans developed for the former MDC properties and J.B. Williams Park. How? The Open Space Management Plans for these two properties are site specific examples of the type of management plan to be developed for forests across the Town. The plans for these two properties would be incorporated into the future comprehensive Forest Action Plan. They also provide many recommendations that will be relevant to other forests and opens spaces throughout the Town with similar conditions.
- As a first step, the office secured a grant to partially fund a comprehensive forest inventory of the Town, providing
 existing conditions information and mapping that will become the basis for a management plan. Existing conditions
 information includes a description and mapping of the tree species, quantities, age and health; the presence and
 mapping of invasive plants; the presence and mapping of tree disease; and to an extent trail and other conditions
 mapping (cultural sites, presence of trash, etc.)
- As of 2014, Glastonbury's 33,413 total acreage was composed of approximately 6,000 acres of publicly and privately owned open space, representing 17.9% of its land area. Of the total open space area, an estimated 3,723.61 acres are Town-owned open spaces and forest land within parks. The MDC and J.B. Williams reports inventoried approximately 661.02 acres, leaving a remaining 3,062.61 acres to be inventoried and assessed in the proposed project.
- A certified forester will survey 1,551 of the 3,062 acres to provide baseline data that will inform us of the composition and health of the Town's forest land. This 50% sampling should be sufficient to provide a clear understanding of the forest conditions.
- Using the following selection criteria, staff chose the properties in the attached map to be surveyed.
 - Anticipated opportunities for passive recreational use (hiking, disc golf, bird watching, geocaching);
 - Proximity to residential properties;
 - Contiguous Town owned tracts;
 - Adjacency to state lands;
 - Lack of existing information or routine observations;
 - Higher frequency of existing public use;
 - Percentage of forest vs grasslands;
 - Potential or known threats of invasive species; and
 - Existence of sensitive species.
- The contract with the forester will be signed this week, after which field work and a community survey will begin. Staff will be providing public informational updates throughout the project. It is scheduled to conclude with a report and data set in December 2024.



IMPORTANT DATES & DEADLINES

Tax Bills Become Due and Payable July 1, 2024

The first installment of Real Estate, Personal Property, and the entirety of Motor Vehicle taxes for the Town of Glastonbury will become due & payable Monday July 1, 2024 and delinquent after Thursday August 1, 2024. These bills are based on an assessment date of October 1, 2023. Past due balances will be subject to interest at the rate of 18% annum, 1 1/2% per month or any fraction of a month from the due date. A minimum of \$2.00 interest will be charged for each delinquent tax bill and installment. Any Real Estate or Personal Property bill of \$100.00 or less shall be due in full. No separate mailing will be sent for the second installment (January). Beginning July 1, you may also access your bills by visiting the Town website at www.glastonburyct.gov/taxpmt. Refuse Permits on Sale Beginning July 1

Refuse Disposal Permits will be available for purchase at the Transfer Station and Bulky Waste Facility during normal operating hours starting July 1. To view current permit fees, please visit the <u>Refuse Permit page</u> on the Town website. Acceptable forms of payment at these sites are credit card, cash, or check.

Permits may also be purchased at the Customer Service Center in Town Hall, Monday - Friday, from 8:00 AM - 4:30 PM (excluding national holidays) by check or cash payment only. Credit cards NOT currently accepted at Town Hall. Summer Safety

Summer Pests

Mosquitoes & Ticks - Mosquitoes and ticks can spread germs that cause diseases like West Nile and Lyme disease. You can Fight the Bite and learn how to protect yourself and loved ones from mosquito and tick bites. The CDC now offers the "Tick Bite Bot", an interactive tool that can assist you with removing ticks and determining when to seek health care. To access the bot, visit the CDC website.

Rattlesnakes - Rattlesnakes can be particularly active during the summer and early fall, and there is a sizeable population in Glastonbury and in neighboring communities. If you see a rattlesnake, calmly and slowly back away and allow the snake to move on. Quick movements can provoke a defensive strike. Be mindful of rattlesnake presence when outdoors with children and pets. To help prevent incidents, walk your yard thoroughly and regularly to ensure there are no Timber Rattlesnakes out warming themselves. They can be identified by colors of yellow or black striping and a rattle at the end of their tail. If you spot a Timber Rattlesnake, please call Glastonbury Animal Control at (860) 633-7227 or the Department of Environment & Energy Protection (DEEP) to have the snake removed and safely relocated back to their den area. If your pet is bitten by a rattlesnake, IMMEDIATELY take them to the closest ER Veterinary hospital that carries Anti-Venom serum to save your pet's life. We recommend calling ahead to confirm that the hospital carries the serum, as not all of them do. For additional information, please visit the CT DEEP website.

CDC recommends The layering sunscreen, hats, sunglasses, protective clothing for optimal sun protection. Be sure to apply broad spectrum sunscreen of SPF 15 or higher every 2 hours and after swimming, sweating, or toweling off. During extreme heat, remember to stay hydrated, wear loose and light-colored clothing, seek shade often, and avoid high-energy activities. NEVER leave a child, adult, or animal alone inside a vehicle as the temperature can rise extremely quickly.

Elderly homeowners tax credit update

The state and local homeowner's tax credit applications have been processed for the 2023 Grand List and applied to each resident's tax account.

The income limit for the state program was \$53,400 while the income limit for Glastonbury's local program was \$69,700. Those who qualify for the elderly state tax credit automatically qualify for the local tax credit.

Of the 617 approved applicants on the 2023 Grand List the tax credits were processed as follows:

In addition, the local homeowner's residency bonus tax credit of \$100 to the residents who qualify for the local program and have been residents for at least 20 years was granted to 282 accounts for an additional \$27,109. The Town grants a total of \$698,298.86 in additional credits to the State of Connecticut Homeowner's Program.
