Police Cadet Application

The Glastonbury Police Cadet post is an official program of the Glastonbury Police Department under the regulation and partnership of the North East Regional Law Enforcement Educational Association (NERLEEA). The purpose of the program is to educate and involve the youth members of the community in police operations, to interest them in possible law enforcement careers, and to build mutual understanding. Cadets learn in both the classroom and field environment, including actual "hands-on" field experience. Regular post meeting presentations including training on police duties, forensic science, self-defense, investigation, and tactics.

At the same time, the police cadet provides helpful service to the police department and are considered a great asset to the community of Glastonbury. They participate in community service efforts, supplement sworn officers in traffic direction and event presence, and are role models to the community at large as ambassadors of the police department.

Police cadets are NOT sworn police officers. They have no arrest powers and are not employed by the Town of Glastonbury. Their participation in the program is voluntary only and a privilege granted to them as outstanding young members of the community.

Requirements: Candidates applying for appointment to the Glastonbury Police Cadet Post must be between the ages of 14-21 and live in the Town of Glastonbury (or neighboring town with no established cadet program). Candidates must be enrolled in school, have a "C" average or better, and have successfully completed the 8th grade. Candidates must be of high integrity and moral character with no criminal history or other significant involvement in delinquent activity. Candidates agree to adhere to all post requirements to include regular attendance at meetings and events.

Instructions: Please fill out the below form completely and accurately – Do not leave any fields unfilled. Candidate must provide a copy of their most recent report card. Candidates must complete the writing sample on the final page to explain why they want to become a police cadet, what they hope to get out of the program and note any additional qualities or considerations.
