Hartford border. Many residents living in this area are already subjected to disproportionate health risks from the volume of traffic, air & noise pollution. More development would make this even more intolerable to existing residents. In 1998 The Connecticut General Assembly passed The Village Districts Act to help towns protect and preserve their neighborhoods, history and character. VD status means future developments would be subject to the same strict guidelines of the ASDRC as the center and south are. The intersection of House St and Salmon Brook just became a 3-way stop. My husband and I have been emailing & calling our police dept for about 12 years regarding speeding cars on our street and Griswold. We're not the only ones. A July Citizen article said that on Griswold St alone, GPD have made 385 traffic stops in a 3 yr period. 385!!! There have been 4 fatal accidents & numerous near misses in one short stretch yet not a single safety improvement habeen made in the 13 years we have lived here. Let's look at disparity at Naubuc school. Naubuc kids could not do the bike-to-school week like our other schools. Our roads are too dangerous. Since the addition of the open classroom block decades ago until the new renovation, our school had not been able to practice a single secure lockdown. How could it without walls or doors? Our children and staff have had only 16 days of clean, filtered air now that we have walls and adequate HVAC. Naubuc children breathe in fumes & particulates from surrounding traffic. Our other schools are surrounded by green space. We should act on VDD & traffic calming with great urgency. More commercial & retail without these measures will make existing problems even worse.
