INTRODUCTION

alastonbury is taking advantage of a Connecticut Energy Efficiency Fund (CEEF)-sponsored and Connecticut Light and Power (CL&P)-administered program to document how our larger facilities should be operated to maximize energy-saving opportunities that improve their overall performance while helping to develop long-term, sustainable energy management strategies. In order to qualify for the program, a facility must: have: direct digital control (DDC) of the heating, ventilating and air conditioning systems; exceed 100,000 square feet; and participate in the EPA Energy Star Benchmarking program.



RETRO-COMMISSIONING OF MUNICIPAL AND SCHOOL BUILDINGS

The facilities that qualify for the program and that are being investigated and analyzed through the CEEF/CL&P retro-commissioning (RCx) program include:

SCHOOLS

- Glastonbury High School
- Smith Middle School (shown at right)

MUNICIPAL FACILITIES

- Police Department
- Riverfront Community Center

To deliver results, CL&P's energy engineers collaborate with the Town and a prequalified RCx engineering firm to use targeted functional tests and



DDC trend analysis to survey, investigate and provide recommendations for **energy-efficiency measures (EEMs)** at our facilities. The cost of this investigation is funded 100% through the CEEF.

After the investigation is complete, the RCx firm provides a detailed implementation plan which details the proposed EEMs, the estimated cost to implement and the estimated energy savings. CL&P reimburses the Town for approximately 50% of the implementation costs. After the EEMs are implemented, the program provides training in the operation and maintenance of the measures and the Town continues to record energy usage through the *Energy Star* Portfolio Manager System to verify expected results.

In the case of Smith Middle School, the investigation identified five EEMs. The cost to implement them is \$101,875 (of which CL&P will pay 50%), and the estimated annual energy savings is \$51,453. This yields a one-year net payback on the Town's investment.
