1) CLARIFICATION: On Pages 00 24 19-9 and 00 24 19-10, under Allowance Nos. 1-11 inclusive, the quantity of wiring and raceways specified is for EACH of the additional items included in the allowances. See example below:

"Allowance No. 1 - Provide two (2) illuminated Exit Signs w/ double face plates, ceiling mounted type, including 100 feet of wiring and raceways for each exit sign."

## A. DRAWING NOS. A-431 THROUGH A-439:

1) CLARIFICATION: On Drawing Nos. A-431 through A-439 inclusive, under the "Glazing Legend" the composition of Glass Types C, G, and K is as follows:

"Type C is a one (1) inch insulating glass unit similar to those specified in Section 08 80 00 except that the inner light shall be Glass Type GS-1 specified in Section 08 41 23."

"Type G is Glass Type GS-1 specified in Section 08 41 23."

"Type K is Glass Type GS-1 specified in Section 08 41 23."
