The Town of Glastonbury will receive sealed bids in triplicate for the Nutmeg Lane Pump Station Upgrade at the Office of the Purchasing Agent, Town of Glastonbury, Town Hall (second floor), 2155 Main Street, Glastonbury, Connecticut 06033 until 11:00 AM local time, April 24, 2012 and then at said office publicly opened and read aloud. Bids submitted after this time will not be accepted. Each bidder must submit a sealed envelope, the outside of which must be clearly marked **"BID ENCLOSED - NUTMEG LANE PUMP STATION UPGRADE - GL-2012-12"**.

The Work involves the conversion of the existing drywell/wet well pump station to a submersible style station, including but not limited to, the demolition of the existing generator building and drywell, the installation of a new water and gas service, the construction of a new masonry building, the installation of new submersible sewage pumps, stand-by generator, piping, valves, heating, ventilation and electrical distribution and control systems.

The Issuing Office is Wright-Pierce, 169 Main Street, 700 Plaza Middlesex, Middletown, CT 06457. Copies of Contract Documents may be obtained upon payment of a non-refundable fee of \$75.00 per set. Partial sets will not be distributed. All requests for mailed documents must be accompanied by an additional non-refundable fee of \$20.00 to cover postage and handling. Checks should be made payable to "Wright-Pierce".

To be considered a responsive Bidder, the Contractor shall have obtained at least one set of paper plans and specifications from the Engineer (Wright-Pierce). The Bid will not be awarded to a Bidder unless a record for the purchase of at least one set of paper plans and specifications exists in the office of the Engineer. To meet this requirement and to establish the record of purchase, a

prospective Bidder must purchase paper plans and specifications using the Bidder's name that is to appear in the Bid Response Documents.

A non-mandatory pre-bid conference will be held at the Nutmeg Lane Pump Station, 105 Nutmeg Lane, Glastonbury, Connecticut, on April 11, 2012 at 10:00 AM. Attendance and participation is encouraged.

A completed Bid Form, Experience Statement, Certification of Bidder Regarding Equal Employment Opportunity, Non-Collusion Affidavit, Glastonbury Code of Ethics Acknowledgement and bid security in the amount of ten percent of the Total Bid must be submitted with the Bid. Copies of all documents except for the Bid Security must be submitted in triplicate. The Bid Security may be either a proposal guaranty bond executed by a surety company authorized to do business in the State of Connecticut, or a certified check drawn upon a bank within the State of Connecticut. Bid Security shall be made payable to Town of Glastonbury, Connecticut. Bids submitted without Bid Security will not be considered. No Bid may be withdrawn for 60 days after receipt of Bids unless released by the Owner.

The successful Bidder is required to comply with all provisions of the Civil Rights Act of 1964, the Equal Opportunity Act of 1972, Executive Orders #3, No. 17, 11246, 11375 and 11478. Contractors shall comply with State Statutes concerning Employment and Labor Practices, if applicable, and Section 31-53 of the Connecticut Statutes, as amended (Prevailing Wages).

The successful bidder must furnish within 15 calendar days after the Notice of Award the required number of copies of the signed Agreement, 100% Performance Bond, 100% Payment Bond, and begin execution of this contract within 10 calendar days following the Notice to Proceed.

The Town of Glastonbury reserves the right to reject any part of, or the entire Bid, to waive any informalities, and to accept any Bid, when said action is deemed to be in the best interests of the Town.

The Town of Glastonbury is an Affirmative Action/Equal Opportunity Employer. Minority / Women / Disadvantaged Business Enterprises are encouraged to bid.
