PERMITS:

Vehicles must display a VALID Town of Glastonbury Refuse Disposal Permit Sticker when using these Facilities. To procure your Permit Sticker, a VALID VEHICLE REGISTRATION and acceptable proof of residency or business must be shown. No permit or disposal fees for electronic devices from residents.

Permit stickers may be obtained at the Physical Services, Engineering office or Customer Service Center at the Town Hall, 2155 Main Street, Monday thru Friday from 8:00 a.m. until 4:30 p.m. or at the Transfer Station/Recycling Center or Bulky Waste Facility during the normal operating hours. Up to one (1) additional \$25.00 permit is available at no additional cost when first permit is purchased (either \$25.00 or unlimited). Proof of initial purchase is required. Prepaid trip /disposal coupons are available at permit sale locations.

Only material generated within Glastonbury is accepted at these facilities. The Town reserves the right to require acceptable proof of material origin, per Ordinance Sec. 8-10. This may include, but not be limited to, providing building permits to validate origin.

UNACCEPTABLE MATERIALS:

Unacceptable materials are hazardous wastes such as pesticides, oil based paints and thinners, or other wastes as designated by the State Department of Energy & Environmental Protection. Demolition material cannot contain, asbestos, or other hazardous material. Household Hazardous Waste Collection information is available by calling the Refuse Disposal office at 652-7772 or the information line at 652-7790.

OPERATING HOURS:

BULKY WASTE: Monday thru Saturday, 7:00 a.m. to 3:00 p.m.

TRANSFER STATION: Tuesday thru Saturday: 7:00 a.m. to 3:00 p.m.

Daylight Saving Period ONLY: Wednesday 7:00 a.m. to 7:00 p.m. **NOTE:** Modified Wednesday hours for last six (6) weeks of daylight savings time are 7:00 a.m. until 6:00 p.m.

RECYCLABLE MATERIALS- TRANSFER STATION ONLY:

The Town of Glastonbury has a recycling policy requiring all users to separate and recycle the following items: Glass and Metal Food & Beverage Containers, Plastic Food & Beverage containers #1 thru #7 and Aseptic Packaging, Newspapers, Scrap Metal, White Office Paper, Corrugated Cardboard, Magazines and Junk Mail, Waste Motor Oil and Filters, Anti-Freeze, Storage Batteries, Leaves, Grass, Wood Chips, Tires, Boxboard (IE: Cereal , Pasta boxes), electronics and used clothing. All the above items must be placed in designated containers/areas at this facility.

SATELLITE RECYCLING CONTAINERS:

LOCATIONS: Corner of Hebron Ave./Manchester Rd. (Rt 83) & behind Town Hall.

ACCEPTABLE MATERIALS: Glass & Metal food containers, Plastic Food and Beverage Containers #1 thru #7, Aseptic Packaging, Newspapers, Boxboard (IE: Cereal, Pasta Boxes) and Magazines and Junk Mail.

- Unlimited permits do not include trailers.
- Vehicle types and associated fees will be determined by Town.

ALL VEHICLES MUST USE OLD MAIDS LANE TO ACCESS THE BULKY WASTE FACILITY.

ALL LOADS MUST BE PROPERLY SECURED per Ct general statute 22A250 (Littering) and Motor Vehicle statute 14-271 (Unsecured Load). Fines for violators are in excess of \$100.00.

DEMOLITION: Building Construction Materials. **DOES NOT INCLUDE:** Recyclables, upholstered furniture, carpeting and appliances.
